2008 Yolo County Employee Service Awards

(Woodland, CA) – During the annual Employee Service Awards banquet held last month, Yolo County recognized and honored 62 employees who have attained a threshold of 15, 20, 25, 30, 35, or 40 years of continuous service to Yolo County. These employees were honored for their commitment and dedication to serving our community.

Of note, Sandy Brown was recognized for her 40 years of service to the county. Ms. Brown came to work for Yolo County in 1967. She spent several years with the Health Department and in 1990, moved to the General Services division. Ms. Brown is currently the Facilities Services Coordinator, a position she has held for a number of years. Along the way she had many accomplishments and successes. To name a few achievements, in 1989, Ms. Brown successfully applied for, and received, state grant funds for purchasing computer equipment to be used for automating the birth registration process. She also successfully coordinated conversion to a new billing and revenue collection system for the Environmental Health division. This streamlined the entire billing and revenue collection process. Ms. Brown is truly appreciated for her 40+ years of dedicated service to Yolo County.

In 1972, Cathryn Lorda was hired as a Library Assistant, and 35 years later she is still going strong. Ms. Lorda has always performed at a top-notch level and in 1988, was promoted to Library Specialist. She has worked her entire tenure with the county in the Yolo Branch Library. She is responsible for the pre-school program at the library, as well as the entire youth and summer reading programs. Ms. Lorda continues to be a valuable employee and we look forward to more years of service with her.

Also in 1972, Yolo County hired John Freeby to be an Administrative Accountant in the Alcohol, Drug and Mental Health Department where he remained for the next 35 years. Mr. Freeby's knowledge and experience with the state and county budget process was invaluable. He was very active in the county's State Fair program, as well as with United Way fundraising campaigns. Over the course of his tenure with Yolo County he was promoted and re-classed several times, ultimately retiring as a Senior Administrative Services Analyst in November 2007.
