Local Mental Health Board Mental Health Director's Report September 28, 2015

#### **Housing Project**

We are working with Yolo Housing Authority and Mercy Housing to finalize the document which will release the MHSA housing funds for use. The document will be posted for a 30 day comment period. The document will include the service plan, budget, timeline and site plan. We will share this with LMHB as soon as it is posted for your review.

#### SAMHSA Substance Use Disorders Implementation Academy

On September 16-17, Karen Larsen participated in a Substance Abuse and Mental Health Services Administration (SAMHSA) Substance Use Disorders Implementation Academy multi-state convening regarding substance use among the Veteran population. Other participating states included Arizona, Montana, Nevada, Washington and Wyoming. Each state met locally with statewide representatives and convened periodically for virtual report outs throughout the two days. The state delegations were tasked with coming up with a plan for intervening in substance use among veterans that could begin within six months. The California delegation included representatives from the California Department of Health Care Services, Veterans Affairs, Veterans Administration, University of California - Los Angeles, University of Southern California, Interagency Council on Veterans, National Guard, and some veteran serving private organizations. The California delegation decided to focus on youth and families of veterans and service members. We will be working to identify veterans in substance use disorder treatment throughout the State and developing education and outreach services for their children and family members, regarding their own risk for substance use, family dynamics of addiction, and coping strategies.

#### 1115 Drug Medi-Cal Organized Delivery System Waiver

On September 14, Karen met with Partnership HealthPlan of California and several other mental health directors from the Partnership Region to discuss the possibility of a regionalized approach to implementing the 1115 DMC-ODS Waiver. This discussion would help the smaller, more rural counties to achieve some of the requirements of the waiver. We will be meeting again to discuss further and decide if this approach makes sense. On September 25, we convened the second provider workgroup to discuss the different elements of the waiver.

#### **Homeless Services**

On September 15, Congressman John Garamendi hosted a Homeless Forum at the Davis Veteran's Memorial Center. The event, held in collaboration with the City of Davis Mayor's Office and Davis VFW Post 6949, included approximately 50 individuals working in the field of Homeless Intervention. Attendees were present from counties in the Congressman's District, adjacent districts and the bay area. The discussion focused on various issues that create obstacles to strong outcomes, such as defining the gap between how national standards measure homeless in each County through a "point in time" count, and the individuals missed in these counts; for example transient individuals and rural, isolated encampments. Other concerns addressed were the generally high costs of housing and lack of housing inventory. Tracy Cascio from the U.S. Department of Veterans Affairs described the increasing efforts in recent years by the Veterans Administration to assist their constituents struggling with homelessness. Ryan Collins, a City of West Sacramento staff member working on the HHSA Homeless Services Team, provided an overview of the Bridge to Housing program as a successful Housing First effort in the local area.

#### **ICD-10 Implementation**

The Adult & Aging Branch hosted a nationally recognized trainer for two, one-day trainings in preparation for the federally-mandated conversion to the International Classification of Diseases (ICD) version 10 claiming for healthcare services provided on and after October 1, 2015. Nearly 100 County and contract provider clinicians, nurses and psychiatrists attended the training by Lisette Wright, M.A., Licensed Psychologist and Executive Director of Behavioral Health Solutions, ICD-10: Coding, Documentation and Clinical Diagnostic Criteria Training©. HHSA Quality Management staff will provide ongoing program support to County and contract providers of specialty mental health and substance use disorders throughout Yolo County during this transition.

#### **Psychiatry Update**

We are happy to announce that we have hired an additional Psychiatrist to join our team. She is a Yolo County resident who has been in private practice and will be joining us for 32 hours per week. Additionally, we are losing Dr. Kevin Rosi, our Child Psychiatrist, effective November 6th and our Medical Director, Arturo Villamor, effective December 4th. We will not be replacing Dr. Rosi, and instead are working with our contract providers to hire part time Psychiatrists to serve the youth they are seeing. As you recall, we contracted out the majority of our Children's services last year. We are actively recruiting for the Medical Director position, conducting a salary survey, and hoping to have this position filled shortly.

#### **Older Adult Services**

After 10 years of service to our Older Adult clients, Nancy Edgar is retiring from Yolo County. We have hired the new Supervising Clinician to replace Nancy. Her name is Julie Freitas. Julie comes to Yolo County HHSA Adult & Aging Branch with a wealth of experience in clinical supervision and program oversight. We are excited to have her skills and expertise in our growing Intensive Recovery Services programs.

#### **Wellness Centers**

We are excited to announce that we will be re-opening the West Sacramento Wellness Center within the next two months. Additionally, we are on track to begin the re-model of the Woodland Wellness Center shortly.
