- 1. Call to Order and Introductions The December 14, 2015, meeting of the Community Corrections Partnership (CCP) was called to order at 1:32 pm.

- 5. Review Funding Request for Approval
  - a. Presentation: Sheriff's In-Custody Edovo Tablet Project Funding Proposal (\$25,000) (Wolfe/Kochly) (Attachment C) (10 minutes) –

Mashan Wolfe and Emily Kochly gave a PowerPoint presentation of the new Edovo tablet program proposal. The Proposal: Pilot a secure tablet-based treatment and educational program in Yolo County correctional facilities to improve inmate access to programs and services. The funding will be provided through the CCP programming funding. After roundtable discussion a motion for approval was made. Motion: Jill Cook, Second Ed Prieto, Vote: Passes unanimously 5:0. Ms. Wolfe and Ms. Kochly will give us an update on how the Edovo tablet program is working in May 2016.

6. Presentation on County Behavioral Health Services for Justice Involved Populations (Larsen) (20 minutes) -

Karen Larsen gave an excellent presentation on County Behavioral Health Services for Justice Involved Populations. The Health and Human Services agency has increased their funding by approximately \$1,378,413 in supporting criminal justice partners in reducing recidivism in both the adult and juvenile justice realm. Some highlights of the presentation:

- Increased Staffing to 12.75 FTEs and Increase Funding by \$1,255,673
- Crisis Intervention Training to seven separate agencies
- Community Intervention Program (SB82)Substance Use Disorder Providers
- Admissions and Level of Care
- Substance of Choice FY 2012 2015
- Residential Provider Data for Cache Creek Lodge, Progress House and Walter's House
- Outpatient Services (completion rates and referrals for both CommuniCare and Phoenix House)

Upcoming Services.....

- Drug Medi-Cal Organized Delivery System
- Detox Facility
- RDP for Jail/JDF Behavioral Health

DA Reisig mentioned the importance of us providing folks with mental health needs that do not quality for Mental Health Court. Chief Cardall states we are currently serving this population up to ten clients, however as part of our current strategic plan we can develop specially courts. CAO Blacklock would like to set up a meeting to discuss the Mental Health Court expansion. Chief Cardall will set a meeting prior and participate in Mental Health Court expansion planning.

7. Presentation on Recidivism Project (Palmer/Mount) (15 minutes) -

Nate Palmer and Steve Mount gave a PowerPoint presentation outlining the Recidivism Matrix and Measuring Recidivism. Each member received two separate handouts. The matrix looks at recidivism at four stages of the criminal justice system over two time periods. The four stages are arrests, jail booking, referral for charges and conviction. The CCP Data Subcommittee chose to start review beginning in 2011 for data consistency. DA Reisig suggested any data reporting be run through the Recidivism Matrix. Chief Cardall states that any future presentations from the DRC will require prior circulation to the CCP members to ensure the review includes necessary analysis.
