8. UPDATE FROM SUPERVISOR PROVENZA, SUPERVISOR JIM PROVENZA

- Supervisor Provenza shared his appreciate for the MCAH Advisory Board and how topics in this area also affect the rest of the population. In addition, Supervisor Provenza shared that the Health and Human Services Agency is moving in a good direction with wrap around services to treat the whole individual. This shift in services is trickling down to partners as well. The Bridge to Housing project is a great example of addressing the needs of the individual on a complete basis providing not just housing but also job skills, anger management, etc.
- The Board of Supervisors has been interested in how childhood trauma affects the whole life span. There is significant work to be done in this area but Supervisor Provenza is very optimistic.
- Gina Daleiden will be the First 5 Deputy Director starting in February. The new liaison from Supervisor Provenza's office for the MCAH Advisory Board is still to be determined.

9. 2015 MCAH Advisory Board Highlights, Stephen Nowicki

- Over the years, the MCAH Advisory Board has been monumental in instigating and growing many initiatives. For example, Universal Screening which is now expanding into Help Me Grow was first discussed at MCAH Advisory Board years ago.
- Part of the MCAH Advisory Board's Role is setting the direction for the local MCAH program. Yolo County is very lucky to have an engaged and empowered community. In 2014, the Advisory Board worked on the needs assessment, and the priority areas of perinatal mood and anxiety disorders and adolescent sexual health were identified. In 2015, the local MCAH program has been developing and carrying out work plans for those priority areas.
- In addition, in 2015, the MCAH Advisory board:
 - Submitted a letter of support regarding limiting e-cigarette use in public areas in the unincorporated areas of the County, which was successfully passed by the Board of Supervisors.
 - Showed their support of maternal mental health by having their photo taken with the Blue Dot for a local social media campaign.
 - Finalized the policy platform.

<u>Community Health Branch Strategic Map</u>

Community Health Branch Strategic Map with 1st Year Priorities Identified

- The local MCAH program sits in the Community Health Branch of the Yolo County Health and Human Services
 Agency. The Community Health Branch is generally made up of population based health services and our work
 focuses on systems, environment and policy, and typically does not provide direct services.
- In October, 18 key staff from the Community Health Branch were led by a consultant in a two day process to build the three year branch strategic map. This map was then presented in a Community Health Branch All Staff meeting for input. This strategic map includes the mission statement from the previous Health Department, developed in 2012.
- Jan reviewed the structure of a strategic map:
 - The circle on the map is what the workgroup identified as the central challenge for the branch over the next three years in order to accomplish the mission.
 - Boxes A D are Strategic Priority Areas, and help identify what needs to be achieved to meet the central challenge.
 - Boxes 1 6 are Strategic Objectives related to the priority area they are under.
 - Boxes E & F are cross cutting priority areas that need to be embedded in all other levels of the map.
- The Strategic Plan workgroup also identified what the top priorities would be for year one of the strategic map, which are noted on the second handout by the colored boxes. Similar and connected objectives are linked together to form tracks of work. Although work will be completed in most strategic objectives through all three years, the purpose of identifying tracks of work is to identify key activities and results and gather data.

What is Help Me Grow?

- Jennifer shared information about Help Me Grow, which was established to provide structural support to universal screening. Currently, there are 10 California Counties with a Help Me Grow program and Yolo County summited their application last week.
- Help Me Grow has four main components: child health care providers, community, call center, and data collection.
 In Yolo County, the community connections are amazing. In the near future, four community liaisons, one at each family resource center, will be hired and trained. In addition, the call center will be up and running. The call center, which will provide information about resources, will be available for health care professions, child care professions, as well as families. Next year, screenings will also be happening at CommuniCare Health Centers.
- Yolo County goals include having families with more knowledge and ease of access to services, incorporating trauma informed practices and utilizing the Strengthening Families framework.
- On the third Friday of every month there is a screening meeting, where training is provided.
- Last year, 252 children (ages 0-2) were screened, with 43 of those being referred for autism or multiple delays.
 One of the biggest known gaps currently is the number of providers who assess for and/or provide treatment for autism. In the next couple of months, there will be additional providers trained on early intervention on autism.
 Additional gaps and barriers will be identified as the program continues. SB946 changed where children get assessments and treatment for autism, previously these went through resource centers but now will go through insurance.

- Stephen Nowicki shared that First 5 has funded five providers at Children's Therapy Center to be trained in Early Start Denver Model. Have already started discussing having paraprofessionals also to be trained to treat 15 children. This is all being done through the Partnership HealthPlan of California Autism Behavioral Health program the only children able to access Early Start Denver model will be low income families in Yolo County. Dr. Nowicki is working with Karen Hopkins to span the continuum at Woodland Behavioral Health, and working on adult transition piece.
- **Kathleen Middings** shared that the Woodland School District will be getting AED equipment, thanks to the help of the Community Health Branch. Jan shared that Kristin Weivoda is the person leading that and she will be working to achieve the same in all Yolo County School Districts.
- Anna Sutton shared that the Blue Dot was selected as a topic at National Postpartum Support International
 Conference in San Diego on June 22 & 23. Anna would love to have photos with all MCAH Advisory Board Agencies
 as well as the MCAH Advisory Board.

- Laurie Somerhausen shared that the garden project "Growing Health Habits, Community Garden model" was selected as an Innovative Initiative at the Let's Get Health California Conference. There will be a panel of staff at the Conference next week.
- **Gina Daleiden** will be starting as the full time executive director at First 5 Yolo starting on February 5th.
