22	Count 1 : On or about February 21, 2016, ERNEST LANE
23	MORALES did commit a FELONY, namely, a violation of Sections
24	21a, 664(a) and 187(a) of the California Penal Code, ATTEMPTED
25	MURDER, in that ERNEST LANE MORALES did willfully, unlawfully
26	and with malice aforethought attempt to murder S.S. age 56, a
27	human being.
28	Count Enhancement 1a : It is further alleged that the

attempted murder alleged above was willful, deliberate and
premeditated within the meaning of California Penal Code
Sections 664(a) and 189, ENHANCEMENT FOR WILLFUL, DELIBERATE AND

Count 2 : On or about February 21, 2016, ERNEST LANE MORALES did commit a FELONY, namely, a violation of Sections 21a, 664(a) and 187(a) of the California Penal Code, ATTEMPTED MURDER, in that ERNEST LANE MORALES did willfully, unlawfully and with malice aforethought attempt to murder S.S. age 23, a human being.

Count Enhancement 2a : It is further alleged that the attempted murder alleged above was willful, deliberate and premeditated within the meaning of California Penal Code Sections 664(a) and 189, ENHANCEMENT FOR WILLFUL, DELIBERATE AND PREMEDITATED ATTEMPTED MURDER.

Count 3 : On or about February 21, 2016, ERNEST LANE MORALES did commit a FELONY, namely, a violation of Sections 21a, 664(a) and 187(a) of the California Penal Code, ATTEMPTED MURDER, in that ERNEST LANE MORALES did willfully, unlawfully and with malice aforethought attempt to murder A.S. age 5, a human being.

Count Enhancement 3a : It is further alleged that the attempted murder alleged above was willful, deliberate and premeditated within the meaning of California Penal Code Sections 664(a) and 189, ENHANCEMENT FOR WILLFUL, DELIBERATE AND PREMEDITATED ATTEMPTED MURDER.

Count 4 : On or about February 21, 2016, ERNEST LANE 1 MORALES did commit a FELONY, namely, a violation of Sections 2 21a, 664(a) and 187(a) of the California Penal Code, ATTEMPTED 3 MURDER, in that ERNEST LANE MORALES did willfully, unlawfully 4 and with malice aforethought attempt to murder J.S. age 3, a 5 human being. 6

Count Enhancement 4a : It is further alleged that the attempted murder alleged above was willful, deliberate and 8 premeditated within the meaning of California Penal Code 9 Sections 664(a) and 189, ENHANCEMENT FOR WILLFUL, DELIBERATE AND 10 PREMEDITATED ATTEMPTED MURDER. 11

Count 5 : On or about February 21, 2016, ERNEST LANE MORALES did commit a FELONY, namely, a violation of Sections 21a, 664(a) and 187(a) of the California Penal Code, ATTEMPTED MURDER, in that ERNEST LANE MORALES did willfully, unlawfully and with malice aforethought attempt to murder Z.S. unknown age, a human being.

Count Enhancement 5a : It is further alleged that the 19 attempted murder alleged above was willful, deliberate and 20 premeditated within the meaning of California Penal Code 21 Sections 664(a) and 189, ENHANCEMENT FOR WILLFUL, DELIBERATE AND 22 PREMEDITATED ATTEMPTED MURDER.

Count 6 : On or about February 21, 2016, ERNEST LANE 25 MORALES did commit a FELONY, namely, a violation of Section 26 451(b) of the California Penal Code, ARSON OF AN INHABITED 27 STRUCTURE, in that ERNEST LANE MORALES did willfully, 28

unlawfully, and maliciously set fire to and burn and cause to be 1 burned and did aid, counsel and procure the burning of an 2 inhabited structure and inhabited property. 3

Case Enhancement a : It is further alleged that ERNEST LANE MORALES was previously convicted of a serious felony within the meaning of Section 667(c) and 667(e)(1) of the California Penal Code, ENHANCEMENT FOR ONE PRIOR FELONY CONVICTION THAT PROHIBITS PROBATION, LIMITS CREDITS, REQUIRES CONSECUTIVE SENTENCING, AND MANDATES PRISON COMMITMENT, in that ERNEST LANE MORALES was 10 convicted of a prior felony as defined in Section 667(d) of the California Penal Code, and listed in Sections 667.5(c) and 12 1192.7(a) of the Penal Code, and Section 707(b) of the Welfare 13 and Institutions Code, to wit, a conviction on December 18, 1985 for a violation of Section 459 First Degree of the California Penal Code, in the County of Yolo. 16

Case Enhancement b : It is further alleged that ERNEST LANE MORALES was previously convicted of a serious felony within the 19 meaning of Section 667(a)(1) of the California Penal Code, 20 ENHANCEMENT FOR HABITUAL CRIMINALS, in that ERNEST LANE MORALES 21 was convicted of a serious felony listed in Section 1192.7 of the Penal Code, to wit, Section 459 First Degree of the California Penal Code, on December 18, 1985 in the County of Yolo.

Case Enhancement c : It is further alleged that ERNEST LANE MORALES was previously convicted of a felony within the meaning

of Section 667.5(b) of the California Penal Code, ENHANCEMENT FOR PRIOR PRISON TERM, in that ERNEST LANE MORALES was convicted of a felony on July 10, 2013 in the County of Yolo, and that ERNEST LANE MORALES served a prison term for such conviction and that ERNEST LANE MORALES has not remained free of prison custody or free of a felony conviction for five years, within the meaning of Section 667.5 of the Penal Code.

Case Enhancement d : It is further alleged that ERNEST LANE MORALES was previously convicted of a felony within the meaning of Section 667.5(b) of the California Penal Code, ENHANCEMENT FOR PRIOR PRISON TERM, in that ERNEST LANE MORALES was convicted of a felony on October 2, 2012 in the County of Yolo, and that ERNEST LANE MORALES served a prison term for such conviction and that ERNEST LANE MORALES has not remained free of prison custody or free of a felony conviction for five years, within the meaning of Section 667.5 of the Penal Code.

Case Enhancement e : It is further alleged that ERNEST LANE 20 MORALES was previously convicted of a felony within the meaning 21 of Section 667.5(b) of the California Penal Code, ENHANCEMENT 22 FOR PRIOR PRISON TERM, in that ERNEST LANE MORALES was convicted 23 of a felony on September 25, 1997 in the County of Yolo, and 24 that ERNEST LANE MORALES served a prison term for such 25 conviction and that ERNEST LANE MORALES has not remained free of 26 prison custody or free of a felony conviction for five years, 27 within the meaning of Section 667.5 of the Penal Code. 28

Case Enhancement f : It is further alleged that ERNEST LANE MORALES was previously convicted of a felony within the meaning of Section 667.5(b) of the California Penal Code, ENHANCEMENT FOR PRIOR PRISON TERM, in that ERNEST LANE MORALES was convicted of a felony on August 4, 1972 in the Federal District Court, and that ERNEST LANE MORALES served a prison term for such conviction and that ERNEST LANE MORALES has not remained free of prison custody or free of a felony conviction for five years, within the meaning of Section 667.5 of the Penal Code.
