# 5. MCAH Director's Report, JAN BABB

#### **MCAH Director's Report**

- Jan shared an update about the Public Health Accreditation process. Just last week, Accreditation staff were trained by the Public Health Accreditation Board. Yolo County is now actively engaged in the process and will begin working with an Accreditation Specialist. Over the next year, the Accreditation team will work to upload documentation that supports Accreditation. After that documentation is transmitted, a site visit team will be assigned and in late spring/early summer of 2017 will conduct a visit. Part of that site visit will be conducting interviews with staff and community partners.
- About half of the programs in the Community Health Branch will be moving to the Gonzalez building sometime in the spring. For WIC, they will be sharing a lobby with the other eligibility programs. It will hopefully open opportunities for better cross program promotion.

#### **Nutrition Division Programs**

- Laurie Somerhausen shared that the Nutrition division is working on their budget; they are getting an increase in the WIC budget but caseloads continue to decline. There will be work on creative outreach and recruitment/retention efforts.
- The Lactation Consultant is currently on leave but when she returns she will be launching a new breastfeeding support program for women employed in areas not as supportive for breastfeeding workers, such as migrant workers.
- NEOP, Cooperative Extension and Agency on Aging Area 4 are working on a three-year work plan for SNAP-ed related nutrition programs.
- Received Active Transportation funding part time outreach specialist for that grant to work with Woodland Schools on safe routes to schools and active transportation. This has been in the works for two years.

## California Children Services (CCS)

• The State is going to redesign the CCS program. Currently, CCS handles the financial, medical and care coordination for the child. The proposed redesign will move the care coordination piece to the managed care provider, in Yolo County that would be Partnership HealthPlan. Yolo County is one of the first six counties to shift to this new design by January 1, 2017. There will be some cases that will stay the County responsibility but that number should lessen with the expansion of Medi-Cal to undocumented children ages 0-19.

# California Health and Disability Prevention (CHDP)

CHDP is working with providers to schedule trainings in the spring on hearing and vision.

Conditional Admission Immunization Schedule

- The Immunization Program has been working closely with the school nurses on these issues.
- The Immunization program is working with Salud clinic to coordinate efforts to help address a potential access issue as noted by the high rate of conditional entries in Washington Unified School District.
- CDPH and California Department of Education have partnered together to audit school districts with a 25% or more of conditional entrance, at which the school would have to pay back money. None of the Yolo County schools fell into this category.
