**Local Agency Formation Commission of Yolo County
Notice of Availability of Draft MSR/SOI and Public Hearing**

NOTICE IS HEREBY GIVEN that on **Thursday, April 28, 2016, at 9:00 am**, or as soon thereafter as the matter may be heard, the Local Agency Formation Commission of Yolo County (LAFCo) will hold a Public Hearing at the Yolo County Board of Supervisors Chambers, 625 Court Street, Room 206, Woodland, CA to consider adoption of a:

MUNICIPAL SERVICE REVIEW (MSR) AND SPHERE OF INFLUENCE STUDY (SOI) OF THE 15 RURAL UNINCORPORATED FIRE PROTECTION DISTRICTS IN YOLO COUNTY

The intent of the Municipal Service Review (MSR) is to review the services being provided by all fifteen Yolo County fire protection districts (FPDs); Capay, Clarksburg, Dunnigan, East Davis, Elkhorn, Esparto, Knights Landing, Madison, No Man's Land, Springlake, West Plainfield, Willow Oak, Winters, Yolo, and Zamora. On the basis of the MSR and in accordance with Government Code Section 56425(g), staff has reviewed the Spheres of Influence (SOI) for each agency and recommends that a SOI Update is necessary. The SOI Update proposes to 1) remove the Yolo and Zamora FPDs from the Knights Landing SOI; 2) remove Knights Landing and Zamora FPDs from the Yolo SOI; and, 3) remove the Knights Landing and Yolo FPDs from the Zamora SOI because they are not necessary, even if these three FPDs choose to consolidate sometime in the future.

The Draft MSR/SOI for the fire protection districts **will be available for public review beginning March 18, 2016 and ending on April 28, 2016 at 9:00 a.m.**, at the office of the Yolo LAFCo and online at www.yololafco.org. To be included in the staff report, written comments on the MSR Study and/or the SOI Update should be returned to the LAFCo office by **April 15, 2016**, either by mail at the address stated below or via e-mail to Yolo LAFCo Executive Officer Christine Crawford at lafco@yolocounty.org. Comments received after that date will be considered also, but included in a supplemental packet to the Commission.

The Commission will receive an overview of the draft MSR/SOI and will consider recommendations for MSR and SOI determinations, and related SOI updates for the Knights Landing, Yolo, and Zamora FPDs. The public hearing will include an overview of comments received and responses to those comments. Public comment will also be taken at the hearing.
