1. Call to Order and Introductions – The March 14, 2016, meeting of the Community Corrections Partnership (CCP) was called to order at 1:34 pm.

 4. Updates –
 - a. CCP Strategic Plan Update: Social Media Policy (Olson) -

Tracie Olson gave a brief update on the Social Media Policy, of our Strategic Plan under Goal 2: Restore victims and the community. An update to the strategic plan language was presented. Proposed changes in the item were postponed to the April meeting for a vote.

- b. Update on CommuniCare Outpatient Services integration at Day Reporting Centers (Palmer) -

Mr. Palmer reports CommuniCare will now serve our Day Reporting Center (DRC) clients in both Woodland and West Sacramento. However, CommuniCare will not provide outpatient services at both locations until the end of April.

5. Proposition 47 Probation Presentation (Fruchtenicht) –

Deputy Chief Fruchtenicht gave an overview of the current Prop. 47 cases. Each attendee received a handout with the current stats. Dan announced a new Prop. 47 sub-committee has been recently formed. They will have the first meeting on 3/22/16 in the Dept. 8 Jury Room beginning at 4:00 p.m. The committee includes:

Discussion regarding court minute orders. Mr. Landry reports the minute orders have been rectified as of approximately a week ago.

Roundtable discussion regarding referrals. DA Reisig requested that there be a standing agenda item for the Prop 47 referrals each month. Mr. Reisig asked of 308 referrals to programs and services how many probationers are now active in programs? Deputy Chief Fruchtenicht will get the statistics narrowed down and report back to the group in the near future.

6. Approve Recommendation to the Board of Supervisors for GED Services at the Day Reporting Center with the Yolo County Office of Education -

- a. Contract Term includes Fiscal Years 2016/17 and 2017/18
- b. Total not to exceed amount of \$164,862.00

Nate Palmer went over the MOU between Yolo County Office of Education (YCOE), Yolo County Probation Department (YCPD) and the Yolo County Day Reporting Center (DRC). The purpose of the MOU is to enable YCOE and YCPD to provide GED Preparation for students at the DRC site. Item sent back to Probation and County Counsel for additional review and inclusion of more refined performance measures. Item coming back for vote on the April agenda.
