5. MCAH DIRECTOR'S REPORT – Jan Babb

- National Public Health Week is the first week in April. The Community Health Branch will be hosting a Public Health & Wellness fair in the parking lot at the corner of Beamer Street and Cottonwood Street on April 6th. Registration for booths still open. The flyer, in both English and Spanish, can be found on www.yolohealth.org.
- The Adolescent Sexual Health program is currently evaluating the data from the first full training module at Juvenile Hall; so far it looks really good. The program has also partnered with the Foster Kinship Care Education (FKCE) program to provide a class on relationship/partner violence and safe relationships to the Independent Living Program (ILP) participants.
- The extension of Medi-Cal coverage to undocumented children is scheduled to happen May 1st.
- Simultaneously, CMSP (the indigent health program) is expanding the coverage to include primary care prevention type visits, which were not covered previously. This is a pilot program. As part of health care reform, Medi-Cal coverage was extended to single adults at certain levels of income. Those individuals were previously covered by CMSP, which has led to saving in the program, which will fund this expansion of coverage.

6. CHILD, YOUTH, AND FAMILY BRANCH REPORT – Alissa Sykes

Jaime Ordonez shared that CHDP has scheduled a hearing training for providers on April 22nd. In addition, there will be
a vision training scheduled in May.

- CCS is still moving forward with the redesign; however at this point, the State is running about eight months behind. There are still several potential issues to work out related to the transition and implementation of the redesign, such as creating a master list of CCS and Partnership approved providers. The advisory board had a discussion around the implications of this redesign and potential challenges. It was recommended that a representative from Partnership HealthPlans of California provide a presentation about the implications for their agency at a future meeting.
