Meeting Minutes

Cache Creek Conference Room; Thursday, March 19, 2015, **4:00 – 5:30 PM**

1. Public Comment

No public comment.

2. Approval of Minutes of February 26, 2015

Minutes of the February 26, 2015 TAC meeting were approved with corrections.

3. Public Works Update (Kokkas)

- *Panos noted a problem with the crack sealing on the Russell Blvd bike path where the cracks had been recently sealed. Apparently too much sealant was used and it is too slippery. The County will try an inexpensive fix on a test section by placing an asphaltic emulsion and sand and then rolling it. If it holds up, the County will try to repair the rest of the path where the cracks sealant was used.*
- *The County maintenance staff has been mowing grass and fixing signs across the County.*
- *The County has purchased some new equipment.*
- *Projects coming up include:*
 1. *Full depth pavement reconstruction of CR 27 from 98 to 99*
 2. *CR 99 West St. to Kentucky toward Woodland and over I-5*
 3. *CR 31/95 left turn lanes*
 4. *CR 86 Dry Slough Bridge in Esparto may move forward in July if money is available from SACOG, an E-76 authorization from Caltrans Locals Assistance is pending.*

5. Caltrans is having a meeting for SR16 and installation of a roundabout near Madison, the proposed roundabout will be staked on the ground for nearby property owners/farmers to see if it is large enough to accommodate their farm vehicles.
 - CR 98 to Solano County line has been funded for design,
 - Will try to get some HSEP funding for CR89 and 27 where there was a fatality
 - Panos noted Map21 is expiring in May and the County is not sure of what funding will be available in coming cycles.
 - Of the County's 800 miles of roads, only 116 miles are federally eligible for funding

4. Yolo Rail Line DVD

The TAC viewed a video titled "Sacramento Northern Railway 1939-40 Final Passenger Service. The video showed the history of the electric rail road from the Bay to Chico.

5. Next Meeting Agenda Items

- Olin confirmed that SACOG representative Renee DeVere-Okie would come to the next meeting (sic-due to planned absences in April, Renee will come to the May meeting). He noted that Renee is the liaison from SACOG to the California Transportation Commission (CTC) and a leader of the Regional Transportation Planning group so she will be able to tell us how the CTC figures into the funding picture for the County.
- Chiles Road at I-80, Olin asked if the County could follow up with Caltrans and Supervisor Provenza regarding the flooding problem and report back if Caltrans might be willing to solve this problem since future flooding might damage all the newly placed pavement.
