NOTICE IS HEREBY GIVEN that on **Thursday, July 28, 2016, at 9:00 am**, or as soon thereafter as the matter may be heard, the Local Agency Formation Commission of Yolo County (LAFCo) will hold a Public Hearing at the Yolo County Board of Supervisors Chambers, 625 Court Street, Room 206, Woodland, CA to consider adoption of a:

MUNICIPAL SERVICE REVIEW (MSR) AND SPHERE OF INFLUENCE STUDY (SOI) FOR THE CITY OF DAVIS AND ASSOCIATED COUNTY SERVICE AREAS

The Draft Municipal Service Review (MSR) for the City of Davis and Associated County Service Areas will be available for public review beginning June 29, 2016 and ending on July 28, 2016 at 9:00 a.m., at the office of the Yolo LAFCo and online at www.yololafco.org. On the basis of the MSR and in accordance with Government Code Section 56425(g), staff has reviewed the Spheres of Influence (SOI) for each agency and recommends that a SOI Update is not necessary at this time. Therefore, no change to either of the agencies SOI is recommended. To be included in the staff report, written comments on the MSR Study should be returned to the LAFCo office by July 15, 2016, either by mail at the address stated below or via e-mail to Yolo LAFCo Executive Officer Christine Crawford at lafco@yolocounty.org. Comments received after that date will also be considered, but may be included in a supplemental packet to the Commission.

The intent of the MSR is to review the services being provided by the City of Davis and the county service areas (CSAs) that get some services from the City; El Macero, North Davis Meadows and Willowbank. The Commission will receive an overview of the draft MSR and will consider recommendations for MSR determinations for each agency. The public hearing will include an overview of comments received and responses to those comments. Public comment will also be taken at the hearing. The Commission will be asked to adopt the MSR determinations.
