9:00 A.M. CALL TO ORDER

1. WELCOME AND INTRODUCTIONS – Michael Wilkes, Chair

The June 9, 2016 Health County meeting was called to order at 9:08 a.m., at which time around the table introductions occurred and quorum was confirmed.

2. CONSIDER APPROVAL OF AGENDA – Michael Wilkes, Chair

4. PUBLIC COMMENT

- **Lisa Suhonos** brought forth a request of Health Council to investigate the property at 633 Short Street West Sacramento that has become a nesting property for 50-75 snowy egrets and black capped night herons. This property has not been maintained and the trees and bushes are overgrown to the point that these large birds have built over 15 nests on the small lot. Due to the number of birds, there is significant dander, feces, odor, and flies and mosquitos. Lisa has been working with West Sacramento Code Enforcement and Fire Department, has filed a formal complaint, and is referred back to West Sacramento Code Enforcement when she has contacted Yolo County Environmental Health. When speaking with biologists, Lisa has been informed that after the nests have been emptied; the trees and brushes will need to be removed so the birds do not return next mating season. Patrick Blacklock volunteered to follow up with the City and Environmental Health.

5. STATE AND COUNTY UPDATE – CAO Representative

- Patrick Blacklock stated the Board of Supervisors will be considering the annual Yolo County Budget at the June 14th meeting. While the Fiscal Year 2016-2017 budget does invest in the County Strategic Goals and Focus areas, such as homelessness, there will be a net reduction of 24 positions. Due to revenues not growing as quickly as personnel costs, those 24 positions which are already vacant, will be removed from the budget. Although some State and Federal revenue sources are growing; the general fund is not, which affects Departments such as Human Resources.
 - Health and Human Services is being very strategic about the vacant positions that will be filled and those released. For example, some positions are being consolidated and duties are being reassigned, while others, such as in Fiscal, will be filled in the hopes achieving more efficiencies in drawing funds down.
- The Board is considering the potential for a County-wide Sales Tax measure. It would be a ¼ cent measure or a ½ cent measure. If successful, the tax measure could potentially provide funding for early childhood education, maintaining County roads, and homelessness programs. This will be considered at the June 24th Board of Supervisors meeting.

- There was a discussion around the Whole Person Care Pilot. This pilot has a complicated financing structure; the County cannot rely on the Whole Person Care Pilot as a source of new funding. Health and Human Services plans to proceed with applying, but will be very strategic about implementation funding and it will be a smaller scale than originally thought.

- Karen Larsen was welcomed to Health Council as the new Health and Human Services Director.
- The Expansion of Full-scope Medi-Cal to undocumented children took place beginning in May. Undocumented children currently receiving emergency Medi-Cal will transition to full-scope Medi-Cal automatically. In addition, Yolo County Children’s Alliance is helping any children on Healthy Kids transition to Medi-Cal.
- Kristin Weivoda shared a video about the PulsePoint App. This app interfaces with dispatch systems and notifies community members who have signed up when someone has suffered a cardiac arrest so that they can respond and assist. Anyone can download this app, learn hands only CPR, and provide assistance when notified. This app has been implemented successfully at the Davis campus, and now is being extended to all of Yolo County. The app has other features such as AED locations, which will be built out later. In addition, data can be collected from the app such as how many people in Yolo County have downloaded it, how many notifications went out. However, the only way to know if someone notified by PulsePoint responded and assisted will be if it is noted in the ambulance and fire department records.

Issues include, school and access issues for youth, sugar sweetened beverages in government buildings, commercial outlets and the issue of promotion and advertising. The process is evolving, so there is not a recommendation to share at this point.

- The nominating committee met via phone in May. The nomination is for Dr. Wilkes and Leslie Hunter for another term in their respective positions of chair and vice-chair.
