Notice is hereby given that on **Thursday July 28, 2016 at 9:00 am**, or as soon thereafter as the matter may be heard, the Local Agency Formation Commission (LAFCo) will hold a Public Hearing at the Yolo County Board of Supervisors Chambers, 625 Court Street, Room 206, Woodland, CA to consider the following agenda item:

Project Title:

Watts Annexation and Sphere of Influence Amendment to the Wild Wings County Service Area (LAFCo No. 918)

Project Description:

The owner of the property (APN: 025-440-044) has submitted an application to amend the existing sphere of influence (SOI) and district boundaries to annex into the Wild Wings County Service Area (CSA). The subject parcel is already developed with a single family residence and recently experienced a failure of its onsite private well. An emergency connection to the Wild Wings CSA water system has already been completed. This SOI and annexation would formalize the extension of CSA services to this existing parcel and was required by LAFCo as a condition of the emergency water connection.
