- 1. Call to Order and Introductions The June 13, 2016, meeting of the Community Corrections Partnership was called to order at 1:35 pm.

Amendment – to our May 9, 2016 minutes as follows:

Discussion of Yolo County Part 1 Crime Trends – (Chief Bellini)

a. Prop 47 Crime Review -

Chief Bellini provided handouts covering Part 1 Crimes in Yolo County. The statistics reflect the first quarter of 2015 and 2016. The information is broken out by Penal Code and the city the crime occurred in. Chief reports the information is based on approximately 45K arrest per year. There has been approximately 15K new calls received in the last three years.

6. Discuss and Approve Updated Reserve Fund Policy (County Department of Financial Services) -

All members agree to change the language in the updated CCP Reserve Policy. The change will be as follows: Item 3: Use of the Reserve. "The reserve should not be used to fund new programs or positions where no permanent source of funding is identified, or for any non-CCP approved purposes." Motion: Dan Bellini, Second: Ed Prieto. Vote: Passes unanimously 7:0

- 7. Approve CCP Treatment Contract Extensions at Recommended Funding Allocations (Attachment B)
 - a. Day Reporting Center Provider: Sacramento County Office of Education \$620,000 added for extension through FY 16-17.
 - b. Fourth and Hope Residential Treatment and Transitional Housing \$220,000 added for extension through FY 16-17.
 - c. Cache Creek Lodge Residential Treatment and Transitional Housing \$140,000 added for extension through 16-17.
 - d. Community Recovery Resources Dual Diagnosis Residential Treatment \$50,000 added for extension FY 16-17.

e. CommuniCare Health Services – no additional funds, extension through FY 16-17, cap remains at \$90,000.

Nate Palmer gave updates on each of the above contracts. All contracts with the exception of Community Recovery Resources Dual Diagnosis Residential Treatment and CommuniCare Health Center will be presented to the BoS June 21st. Chief Cardall reiterated the importance of no direct recommendations on mental health treatments. We will request an assessment regarding mental health treatment, i.e., hospitalization, inpatient services. We will then follow the proper protocols of Medi-Cal services and reimbursements.

A motion was made to approve the above contracts as outlined. Motion: Dan Bellini, Second: Ed Prieto. Abstained: Tracie Olson. Vote: Passes unanimously 6:0
