In Custody Forensic HHSA Services

- HHSA In Custody Assessments
 - ▣ Mental Health Court Misdemeanant
 - ▣ Incompetent to Stand Trial
 - ▣ Mental Health Services Following Custody
- CFMG (In Custody Medical) Coordination

Goals

- Assessments
 - Assess needs and recommend appropriate placement
 - Conduct linkage to appropriate out of custody services (HHS Care Team or other community providers)
 - Increase treatment engagement and reduce timeframe between release from custody and first provider appointment

- CFMG Coordination
 - Support continuity of care between mental health, medical and psychiatric care providers, including medication coordination

Other In Custody Services

- Public Defender Social Workers
 - ▣ Referrals only from Public Defender Attorney
 - ▣ Court Reports (Social History, Alternatives to Custody)
- Monthly MDT Meetings (Sheriff Office, Probation, HHSA, CFMG, Day Reporting Center, Phoenix House, YCOE, Empower Yolo, Public Defender Social Worker)
- 1170 split sentence planning and support

Goals

- Public Defender Social Workers
 - Work as part of a holistic legal defense team
 - Provide supportive services to clients of the Public Defender
- Monthly MDT Meetings
 - Increased communication between in & out of custody providers
 - Collaborative release planning & maintain continuity of care
- 1170
 - Increase number of post-release referrals to support services
 - Decrease number of post-release FTA's

Out of Custody Forensic HHSa Services

- Mental Health Court
 - Began in 2013
 - Currently has 13 participants (12 – HHSa FSP Clients)
 - Minimum 18 month program
 - 2 successful graduates (3 more anticipated this year)
- Misdemeanant Competency Restoration
 - Placed in the community (Ideally!)
 - Treatment to Restore Trial Competence
 - Review of charges, courtroom language, legal proceedings, etc.
 - Court Progress Reports
 - Certification of Restoration to Competence
- PRCS Collaboration

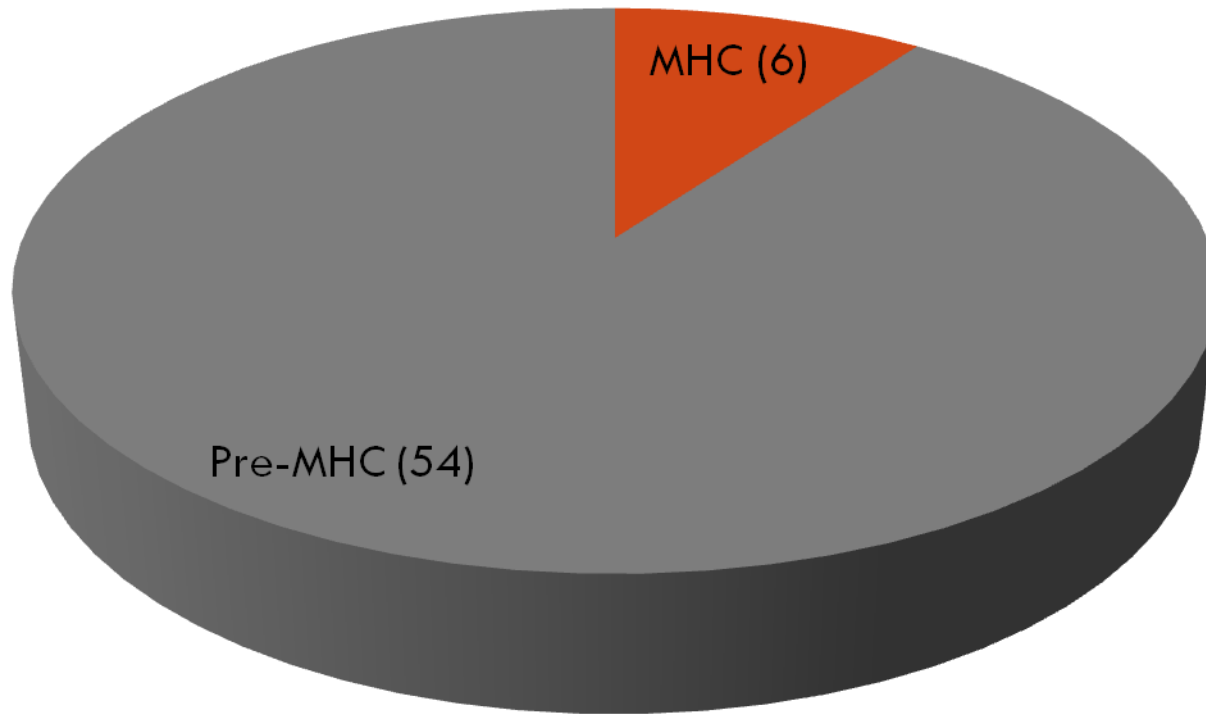
Goals

- Mental Health Court
 - Reduce # of: arrests, jail bed days, hospital bed days
 - Increase: treatment engagement, mental health stability, substance use recovery
 - Improve: the overall quality of life for the MHC participants

- Misdemeanant Competency Restoration
 - Restore client to competency in the most appropriate, but least restrictive environment, so that legal proceedings may continue
 - Provide necessary services and support to aid in client's stability

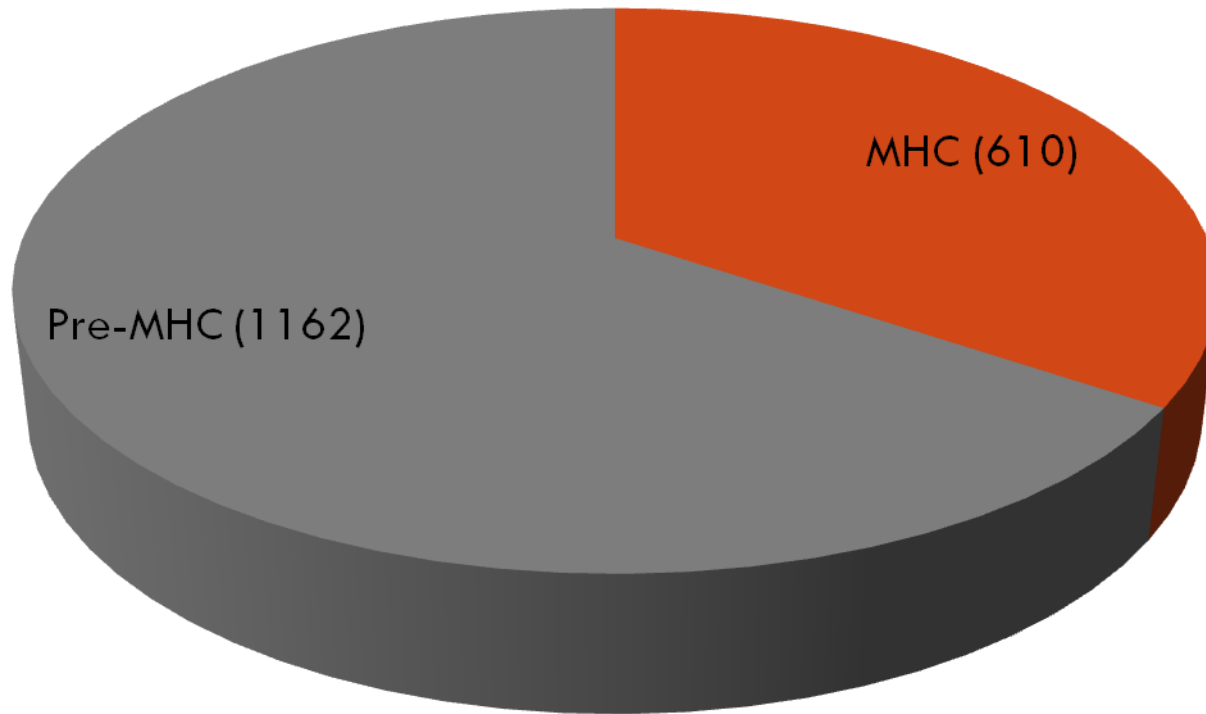
Mental Health Court Outcomes

Mental Health Court Outcomes

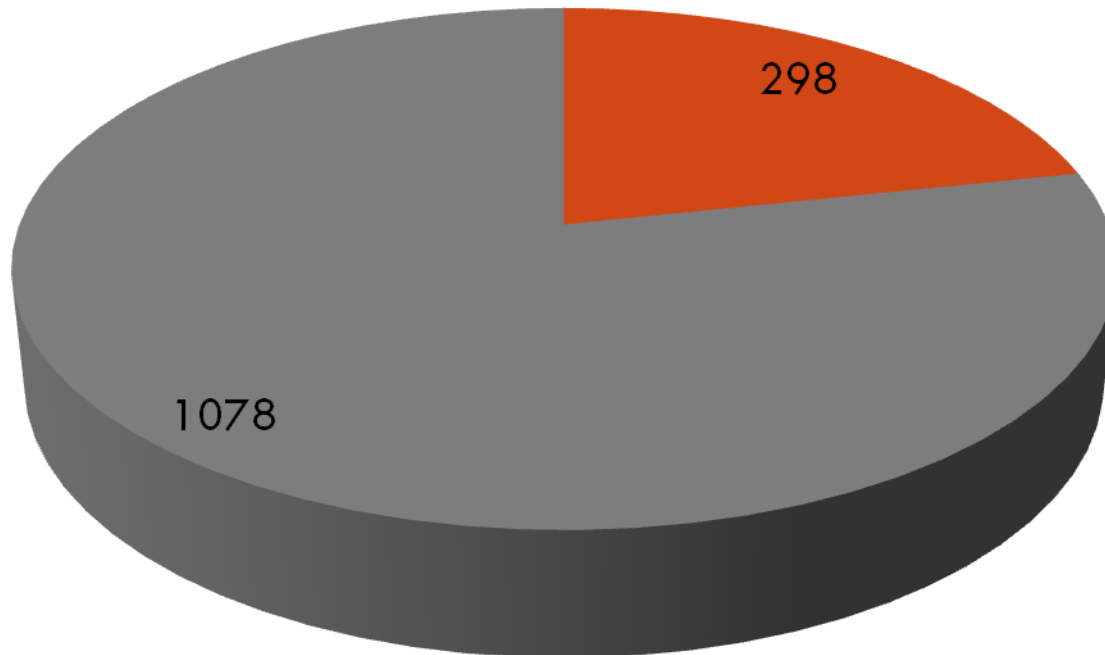
Days Incarcerated: 47.5% Reduction



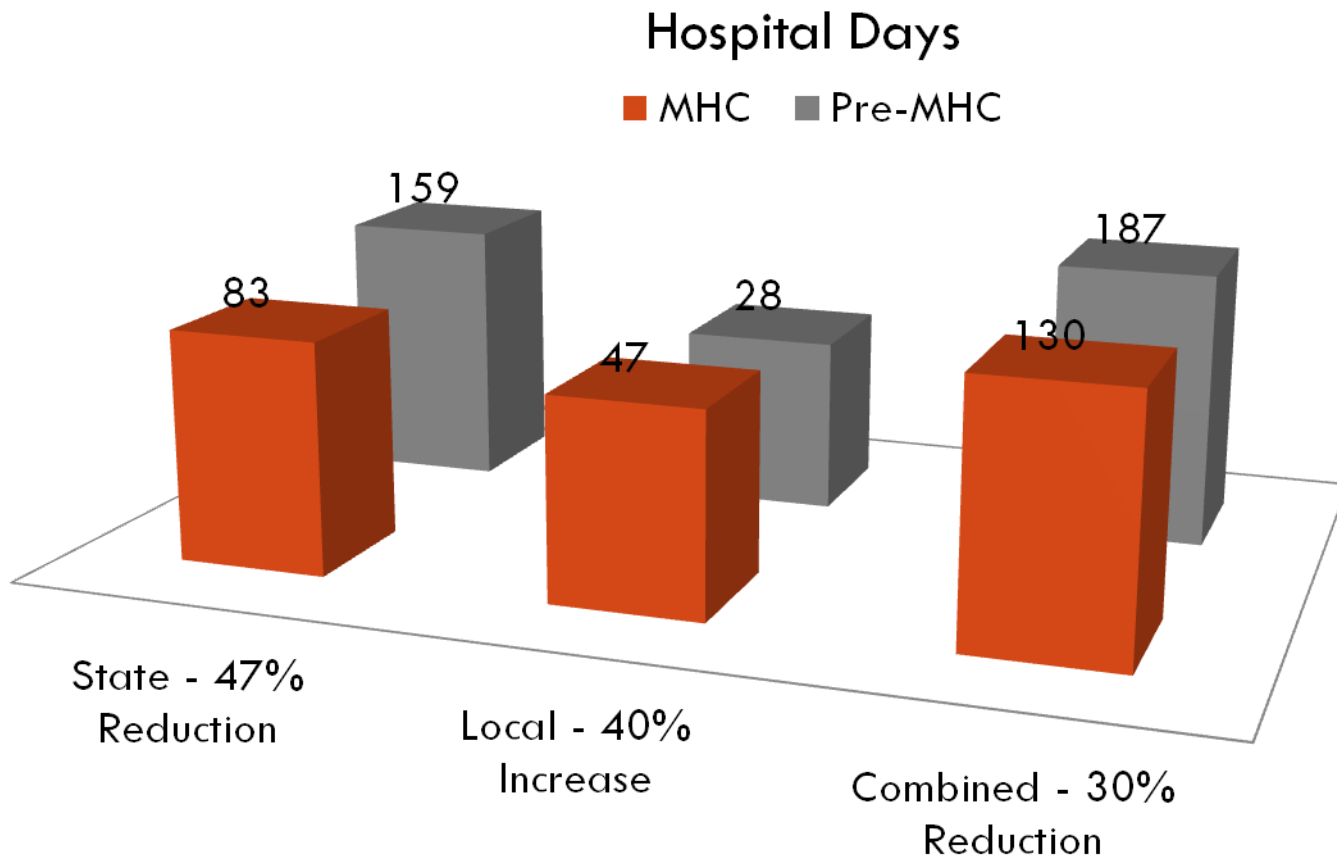
Mental Health Court Outcomes

■ MHC (-312) ■ Pre-MHC (-84)

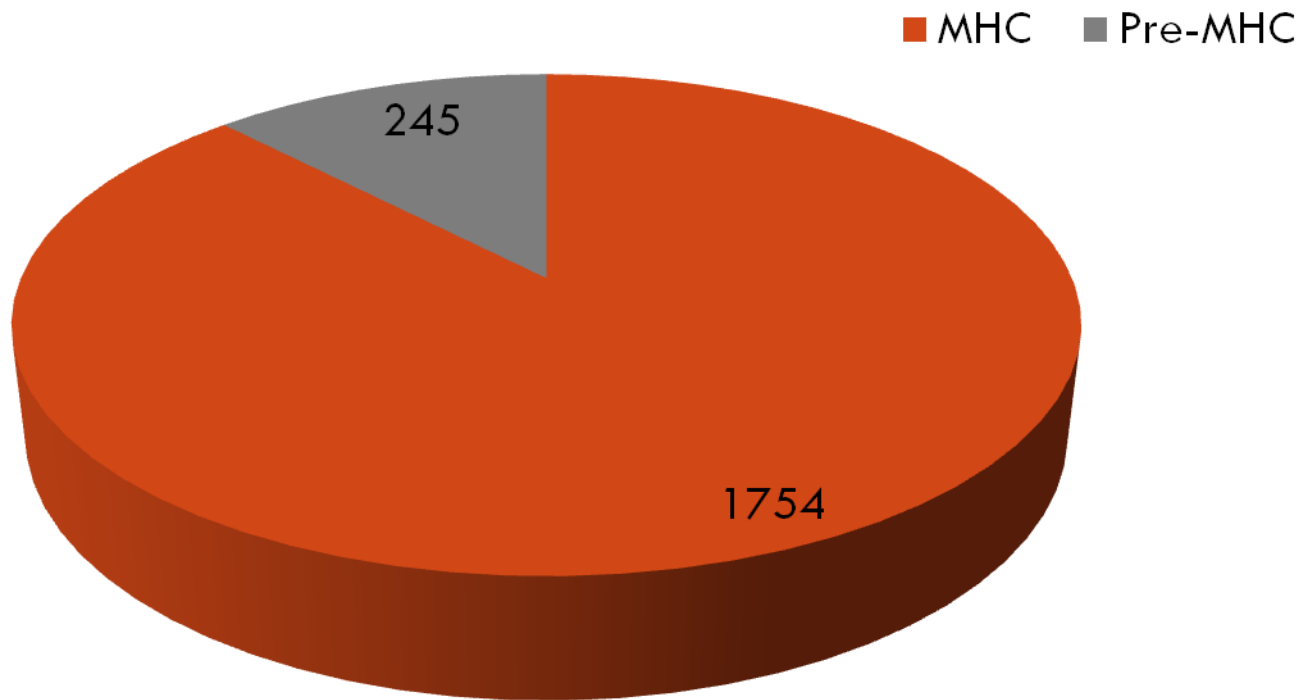


Mental Health Court Outcomes
