- The Immunization Program is working hard to make sure that children can start school on time. Due to the implementation of SB277, which removed the personal belief exemption, there are a large number of children who are scrambling to receive the required vaccinations. While HHSA does have a small clinic on Monday afternoons, there is also the need for all medical providers to take a look at what is offered at their own facilities. The HHSA clinic has certain eligibility requirements.
 - If you would like to look up a school to see their immunization rate, or for other immunization related resources, www.shotsforschool.org
 - Dr. Nowicki shared that the CDC has [guidelines for medical exemptions](#), which would be a good rate to watch over the next few years.
- The hospital breastfeeding rates for 2015 were recently published. In Yolo County, the delivery hospitals are doing a fantastic job with 88% of infants exclusively breastfeed.

 - Shared that the Step x Step program will be moving into the Bauer building next week, which will also lead to some restructuring in the Davis office.
 - Shared that their programs participated in a Back to School Fair in West Sacramento. There were about 500 attendees and great participation. The fair offered backpacks, school supplies, and connections to vendors and support.
 - Willy is working with Anna Sutton on Moving Beyond Depression. Step x Step will be trained on how to submit referrals for this upcoming program. The training for home visitors will be on November 3rd.
 - YCCA will be hosting the Family Fun Barn again at the fair this year. Please stop by!
 - Willy will be running 100 miles to increase awareness for YCCA.
- **Lizeth Betancourt** shared that the Rock and Relax space will be available again at the Fair. In addition, the WIC clinic will be moving to the Gonzalez building in the near future. Some of the staff have already moved.
