**9:00 A.M. CALL TO ORDER**

1. **WELCOME AND INTRODUCTIONS – Michael Wilkes, Chair**  
The September 8, 2016 Health County meeting was called to order at 9:05 a.m., at which time around the table introductions occurred.
2. **CONSIDER APPROVAL OF AGENDA – Michael Wilkes, Chair**  
Quorum was not met.
3. **APPROVE THE [JUNE 9, 2016 MINUTES](#) AND [JULY 16, 2016 MINUTES](#) – Michael Wilkes, Chair**  
Quorum was not met.
4. **PUBLIC COMMENT**  
None at this time.
5. **STATE AND COUNTY UPDATE – Mindi Nunes, CAO Representative**
  - **Homelessness:** Before the governor for signature is a homelessness bond that will allow for permanent supportive housing grants in local communities, specifically focusing on those that are chronically homeless with mental health issues.
  - **Budget:**
    - There have been lower State revenues than anticipated, which has the potential to impact local budgets.
    - The County will be taking their adopted budget to the Board of Supervisors on September 27<sup>th</sup>. It is a very tight budget, with no new positions added. Priorities will be to fund the strategic plan initiatives.
    - HHS is in the process of reviewing their budget. Due to shortfalls with state and federal revenues, HHS may have to look at County general funds to help fill the gap.
  - On October 4<sup>th</sup>, County Administrators Office will be working with the Board of Supervisors on the second year of the three year strategic plan.
  - **Yolo Adult Day Health Center Update**
    - CAO office does not have an update at this time but Health Council member Dawn Myers Purkey offered the following update: discussions between the County and Dignity Health have continued.

The County's goal is to find a place for expansion and Dignity seems interested in being part of the permanent plan.

6. BOARD OF SUPERVISORS UPDATE

- The Board of Supervisors did not have any meetings in August, so next Tuesday will be the first meeting since July.
- **Refugee Resettlement:** Dr. Chapman, along with representatives from Supervisor Saylor's office, met with four local active resettlement groups. One of the first requirements when a refugee arrives is a health screening. Yolo County is not currently designated as a refugee resettlement area, even though refugees are now settling here. The group that met is working to understand what types of services are needed to help these individuals when they arrive.
  - Dr. Wilkes suggests a Saturday morning forum to bring together community workers to discuss ways to support refugees.
- **Youth Regional Treatment Center:** Indian Health Services is planning a Youth Regional Treatment center on Road 31, on the same property as the DQ University. They would serve Native American youth with substance abuse issues throughout California. There are ten of these facilities around the county with two sited for California. Indian Health Services has been working on identifying a location for the last four years. There is work being done with the Board of Supervisors to identify and solve any implementation issues such as land use, fire, access, etc. Construction is anticipated to start in 2017 with operations starting in 2018.
- **Cannabis cultivation** is topic being discussed at every County. This year, the State has set out regulations and statues on cultivation, which allows control over what happens to the environment. Work is being done with the individuals in the industry to develop permits. There are between 800-1000 growers in Yolo County, with the majority being personal use grows. Statewide, it is limited to one acre per grow. In November, there is the potential for additional change as well, depending on the outcome for Prop 68. Yolo County currently has a draft interim ordinance in place.
- **Suicide Prevention** Fundraiser on September 24<sup>th</sup> at the Davis Odd Fellows from 3:00 – 5:00 pm.
- **Sugar Sweetened Beverages:** The report from the sugar sweetened beverage tax that Berkley adopted was recently released. There has been a 20% reduction in consumption. There is a sugar sweetened beverage tax committee that will be restarting.
- **Oral Health Committee** is working on strategic planning. There have been staff changes from the County but dentists continue to be committed and eager.
- This is **Emily Henderson's** last meeting. She has been a fantastic support to Supervisor Saylor, as well as the Health Council.
- **Child Welfare Services:** The Board of Supervisors is looking into the practices and policies to identify areas of improvement. A series of workshops have been scheduled, that are open to the public, with the next one scheduled for September 27th.
