- 5. MCAH DIRECTOR'S REPORT Jan Babb HANDOUT: MCAH DIRECTOR'S REPORT
  - Nurse Home Visiting (NHV) team will be part of an outreach event on October 1<sup>st</sup> called the Community Baby Shower. This event is targeted at pregnant women and families with young infants.
  - AFLP currently has a caseload of 30 parenting teens.
  - Anna Sutton is continuing to work on getting the Moving Beyond Depression contract finalized.
  - Anna Sutton is in the process of hiring a new Public Health Nurse, who will be taking on FIMR and the Prenatal Services Coordinator (PSC) roles.
  - October is SIDS and pregnancy loss month. An info-graphic of SIDS data pulled from Yolo County cases over the last 5 years is available <u>HERE</u>.
  - Ramy Husseini will be sending a letter to school principals about the California Healthy Youth Act. This letter will remind schools that as of January 2016 they are required by law to teach comprehensive sexual health and that Ramy is available as a resource for technical assistance.
  - Ramy Husseini also shared that Foster Care branch of CDSS released the first public draft of teen pregnancy curriculum. Yolo County is currently using it with the ILP program.
  - Jaime Ordonez shared an update on CCS redesign. SB586 is on Governor Brown's desk pending signature. Yolo County is working closely with Partnership HealthPlans of California to facilitate a smooth transition. The bill, once signed, will go into effect for Yolo County no sooner than January 2018.

- Kathi Middings: Kathi has noticed a trend in immunizations in that parents are having issues providing proof of immunization status even though the child actually has been vaccinated. How is the County following up with schools regarding that and conditional entries?
- Lizeth Betancourt shared that UCD will be hosting a breast milk drive in December, more information to come.
- Jenifer Newell is involved in an Inter-Disciplinary Partnership Council at Sutter Davis. They are currently recruiting for previously patients who would be willing to committee to monthly meetings for the next year or two to sit on the advisory council. - Willy Onate shared that the West Sacramento Family Resource Center will be hosting a Harvest Festival on October 26<sup>th</sup> from 4:00 7:00 pm. A flyer should be finalized and ready for distribution soon.
- Yolo County Children's Alliance is preparing for Community Give Away Day on November 19<sup>th</sup>. Typically, this event provides between 300-400 turkeys, coats, and other items to families in need. If you are interested in volunteering, please contact YCCA.
- Step x Step will be moving to the Bauer Building in Woodland in the next week.
- Willy participated in a 100 Mile Run to raise awareness for YCCA in September, and was able to raise some money. Willy may possibly being doing this again next year.
- **Stephen** Nowicki shared that Woodland Health Care continues to bring on new staff in his Department. In addition, Woodland Health Care is expanding to east Woodland by Costco.
- Help Me Grow will be launching a new website this month (<u>www.helpmegrowyolo.org</u>), in addition to expanding the call center (844-410-GROW). Help Me Grow has transitioned to California Therapy Center, where there are Tuesday and Sunday night playgroups.
- Jan Babb shared that The Yolo County Child Abuse Prevention Committee completed a strategic planning meeting yesterday. The Committee decided to focus on building parental resiliency. There was great representation at the meeting of family-serving agencies. The work will be focused on developing Community Parent Cafes; educational events driven by community members.
