

**Yolo Local Agency Formation Commission
Notice of Public Hearing**

Notice is hereby given that on **Thursday, November 10, 2016, at 9:00 am**, or as soon thereafter as the matter may be heard, the Local Agency Formation Commission (LAFCo) will hold a Public Hearing at the **Woodland City Council Chambers, 300 First Street, 2nd Floor, Woodland, CA** to consider the following agenda item:

Project Title:

Madison-Esparto Regional County Service Area Reorganization (LAFCo No. 919)

Project Description:

On June 27, 2016, the Yolo Local Agency Formation Commission (LAFCo) received an application from Yolo County initiating proceedings to dissolve the Madison-Esparto Regional County Service Area (MERCSA) and transfer existing municipal services to the Esparto Community Services District (CSD) and the Yolo County Flood Control and Water Conservation District (YCFCWCD) as detailed in the attached map. Dissolving MERCSA was recommended by LAFCo in its latest Municipal Service Review of these agencies, and both the Esparto CSD and YCFCWCD have agreed to take over MERCSA's services. Also included in this proposal, the Esparto CSD would be granted a new power of Recreation and Parks accordingly.

Section 57077.1(c)(1) of the Cortese-Knox-Hertzberg Act authorizes LAFCo to order the dissolution after the public hearing without holding protest proceedings or an election (when dissolution is self-initiated by the district board). Therefore, please contact LAFCo with any issues or concerns either prior to the public hearing or at the public hearing itself.

Location:

MERCSA's boundaries are generally located north of County Road 26, south of Cache Creek, east of County Road 85B and west of County Road 93, and includes the communities of Madison and Esparto. Please see the map below.

Environmental Review:

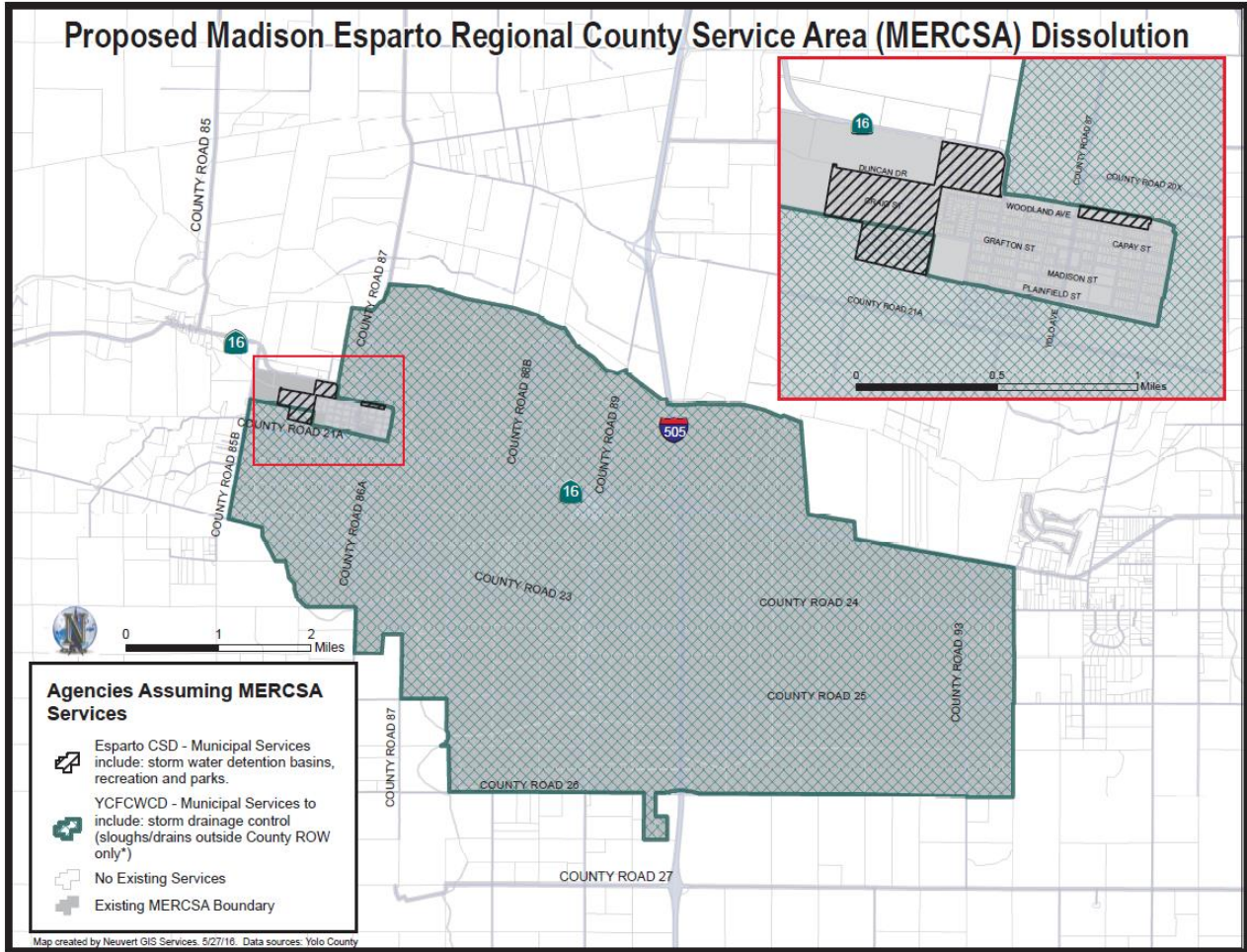
