

PROGRAM FEATURES:

- Manage chronic and complex conditions in community setting
- Personal care assistance
- Respite for families caring for an individual with dementia
- Community education, counseling and support groups
- Interdisciplinary team work with whole person and family (person centered). Includes home visit.
- Coordination with MD's and other health providers (high touch care coordination). Reduces doctor office visits.
- \Box Currently have 86 people enrolled. Average days/week = 3

3 KEY COMPONENTS TO PROGRAM STRUCTURE

Woodland Healthcare

- Fiscal managers since 1998
- Staffing
- Medi-Cal certification
- Grantee for multiple grants

Yolo County

- Holds license for ADHC (program start 1984)
- Contracts with Woodland Healthcare for ADHC
- Owns and maintains building

Friends of Adult Day Health Care

- Fundraising
- Community Outreach
- Separate 501 C (3)
- Founded program in 1984

CURRENT CAPACITY STATUS

Average Daily Attendance (ADA)



- Current licensed capacity is 59 per day
- Currently have 75 individuals on a waiting list
- Waiting list length of time averages 11 months

Driving Growth:

- "Graying of America"
- Affordable Care Act
 Triple Aim Aligned:
 Improved quality, Better
 Outcomes, Saves Money
- Consumer demand for community-based long term care.
- 1 out of 4 individuals over age of 65 care for a person with dementia
- 25% of family caregivers are clinically depressed

ACHIEVEMENTS

- Reduces average hospital days (24.1%), emergency room visits (23.6%) and readmissions by community based management of chronic and complex conditions.
- Improved health outcomes for caregivers caring for a dementia patient (respite, support groups, counseling).
- Integrated person-centered care model

CHALLENGES

- Space, Space, Space! Currently not meeting community need and demand is growing.
- Reimbursed by Partnership Healthplan at \$90/day; actual cost is \$109/day. Program \$ losses significant due to space constraints.
- Davis participants spend over 90 minutes one way in transport.
- Current County and Dignity Health collaboration effective but not desirable for future. Difficult to modify with current \$ constraints.
