3. INTRODUCTIONS AND PROGRAM UPDATES

Attendees shared updates.

4. DRUG MEDI-CAL PRESENTATION

lan Evans provided HPAC with an overview of Yolo County's Drug Medi-Cal Organized Delivery System (DCM-ODS) implementation plan. The plan aims to achieve the following:

- Create a continuum of care modeled after the American Society of Addiction Medicine Criteria for substance use disorder treatment services
- Enable more local control and accountability
- Provide greater administrative oversight
- Create utilization controls to improve care and efficient use of resources
- Implement evidence based practices in substance use treatment
- Coordinate with other systems of care

lan explained that the County hopes to submit its plan by the end of November. Thereafter there is an arduous approval process.

5. HPAC OFFICER ELECTIONS

HPAC's Nominating Subcommittee sought clarification from the full body regarding its election process. More specifically, the Subcommittee needed guidance on how to treat the positions of Chair and Vice-Chair.

- Option 1: Treat them separately
- Option 2: Treat them together and elect the person with the highest number of votes as Chair and the person with the second highest number of votes as Vice-Chair

Ultimately, HPAC decided to treat the positions separately and allow members to run for more than one position.

6. REVIEW DRAFT 2017 HPAC MEETING SCHEDULE

HPAC adopted its 2017 meeting schedule with one amendment. HPAC eliminated the January 25, 2017 meeting as it coincided with the point-in-time count.

7. ANNUAL REIVEW OF HPAC GOVERNANCE DOCUMENTS

HPAC reviewed its governance charter and policies and procedures manual. HPAC re-adopted both documents with no amendments.
