Universal Waste Regulations

Universal Wastes (UW) are common products that, when disposed of improperly, pose risks to human health and the environment. State law requires UW to be taken to a facility that will recycle or properly dispose of universal waste.

It is illegal to dispose of universal wastes in the garbage. By doing so, you risk injury to not only your garbage handler but, in the long run, to everyone. Eventually, chemicals in illegally disposed materials end up at the landfill where toxic metals and corrosive substances can be

released into the environment and can contaminate our air, water and possibly the food we eat.



Yolo County's Household

Hazardous Waste Program collects UW from businesses by appointment every Friday for a fee. To obtain a Quote Request Form please contact Yolo County's Recycling Coordinator at (530) 666-8856. An EPA ID# is <u>not</u> required when transporting or properly disposing of UW.

Small Businesses

UW Items Include:

Batteries

All household batteries including alkaline (AA.C.D), button cell, cell phone batteries, lithium-ion rechargeable batteries and nickel cadmium (Ni-Cd) batteries.

Businesses require an Appointment & Fees Apply

Light Bulbs

Compact fluorescents (CFL's), fluorescent tubes, high intensity discharge, metal halide, sodium and

neon. (Incandescent, LEDs, & halogen light bulbs are not included under UW regulations.)

Mercury Containing

Devices (Other)

Including thermometers, gauges,

switches, "light-up" shoes, singing greeting cards and flashing jewelry (all contain batteries)

Non-Empty Aerosol Cans that

Contain Hazardous Materials

Many aerosol cans contain flammables, like butane, as propellants for products like paint. If your aerosol can



is labeled with words like TOXIC or FLAMMABLE they most likely fall under the universal waste category and should not be placed in the trash.

FREE Disposal Options for Other Hazardous Items Include:

Electronic Waste

Including cell phones, computers and peripheral equipment, pagers, radios, VCRs, DVDs, answering machines and TVs.

Accepted 7-days a week. No charge.

Microwaves

Microwaves fall under the universal waste regulations and under the electronic waste

category. They cannot be put in the regular trash.

Accepted 7-days a week. No charge.

Mercury Thermostats

The County is partners with the Thermostat Recycling Corporation (TRC offering free disposal options to businesses who remove and manage old mercury thermostats.

Lead Acid Batteries

- Unlimited quantities of lead acid batteries are accepted.
 - If batteries are inside a casing

such as a DC Power Supply Unit or Charging Station, remove from casing before recycling.

Accepted 7-days a week. No charge

Latex Paint

- Unlimited quantities of latex paint are accepted.
- We encourage those with large volumes of paint (50gallons or more) to come on a Friday or Saturday when hazardous waste staff can help you unload.
- Additionally, if you have (300-gallons or more) you may call 1-855-724-6809 to request at free pickup at your business.

Oil-Based Paint

- Businesses may only transport up to 27-gallon of oil based paint to qualify for free disposal.
- Upon arrival at YCCL you will need to sign a log letting the County and Paint Care know your business name and contact info.
- If you have more than 27-gallons of oil-based paint you will be required to make an appointment and come through on a Friday. There is no charge for this however additional paperwork is required.

Used Motor Oil and Filters

- A pump is available to assist farms, ranches and other businesses to pump oil from drums into our main oil tank.
- There is no limit on the number of oil filters that can be dropped off as this program is fully funded by a grant by CalRecycle.
- Accepted 7-days a week. No charge.
