Yolo County - Marissa Juhler

- Yolo County Fair
 - o 1st place ribbon awarded for a recycling themed booth exhibit, all cities participated.
 - Sacramento Conservation Corp collected all recycling during the fair

- Central Landfill hours changed for Sundays as of 9/6/15. New hours: 8am to 4pm
- September 19th- Annual Coast/Creek Clean-Up Event (Saturday)
 - o new location added this year the Knights Landing boat ramp
- October 17th- Special Waste/Recycling Event in Dunnigan (Saturday) at Ritchie Bros. yard
 - o Any county/unincorporated county resident can bring tires, paint, E-waste, and more...
- CA Product Stewardship Council (CPSC) new pilot battery program for rural communities
 - o Starting next week at Yolo, Knights Landing, and Clarksburg libraries only
 - Boxes for drop-off the more convenient, the more people are willing to recycle.

City of Davis - Jacques Franco/Jennifer Gilbert/Larry Fisher

- ToReMa Davis store (Totally Recycled Materials) to replace Davis Builders Outpost (Larry)
 - o Developing a business plan, looking for a site location and a "social impact investor"
- UC Davis apartment move-out event, facilitated recycling and reuse at 45 different properties
 - o 66 donations sites in Davis, 13 non-profit groups over 70 volunteers participated
 - Turn-over of almost 2000 individual apartment units over a 5 day period
 - A great success! Goal for next year is to include mattress recycling (Jennifer)

Public/Schools - Dorothy Peterson

- Last year of the pilot compost program in our schools, Davis is more prepared than others
 - Middle school programs are strong, junior and senior high level are a challenge
 - o City of Davis staff will help with more school outreach in classrooms and assemblies

City of Woodland - Reyna Schenck for Roberta Childers

- Rosie is continuing to work with businesses on recycling program compliance
- October 17th Annual pharmaceutical take back event, 8am-12 noon at the Municipal Svc. Ctr.

City of Winters - Carol Scianna

- Creek/Coastal Clean-Up event on 9/19/15 Putah Creek Council is taking volunteer sign-ups
- City is waiting for a new contract proposal from Waste Management
- A new downtown hotel project is going up with a conference center and commercial restaurant
 - Businesses are working to alleviate congestion of alley ways by moving dumpsters for trash/recycling/compost researching ideas for compactors.

3. MAC (Meeting of Area Coordinators) Update - Marissa Juhler

November 14th is the next regional used oil filter exchange event at Napa & O'Riley stores

4. Organics Update and Rate Review – Marissa Juhler/Linda Sinderson

- Marissa provided a proposed rate sheet including all green waste and food waste options
- Organics program set to begin in April 2016 in response to CA's mandate and the cities' needs
- County will submit permitting documents to LEA in December, including composting revisions
 - Solid Waste Facility Permit & the Waste Discharge Requirements
- Questions and discussion followed:
 - o Topics included volume limitations, load contamination, and origins of cost analysis
 - Abel from Zanker Recycling provided insight to onsite and off-site processes
 - Jennifer from the City of Davis spoke about educational outreach for their city
 - Aaron from Zanker Recycling noted potential commercial sources for food waste
 - All program changes and fee amendments will go to the Board of Supervisors
