1. Pledge of Allegiance

Helen Voss led members in the Pledge of Allegiance.

2. Introductions

3. Public Comments

Bill Pride expressed his concern about the proposed federal budget and health care reform. The board agreed that if enacted as proposed both would severely affect the local services available to low-income individuals and families. The board discussed ways it could advocate against the potential cuts and reforms including contacting elected officials.

6. Board Vacancy update

Tracey Dickinson explained that three board vacancies remain. Tracey shared that Supervisor Saylor is interviewing two candidates for the District 2 seat. The board discussed other recruitment strategies, including having the County disseminate another CSAB-specific press release.

7. 2016-17 Community Action Plan Review

Tracey Dickinson provided an overview of the past community action plan. She reminded members that the plan is based on the findings of its bi-annual community needs assessment. Tracey encouraged members to reread the 2016-17 plan in preparation for the 2018-19 plan.

8. 2018-19 Community Action Plan Overview

Tracey Dickinson provided members with a timeline of proposed activities related to conducting the 2018-19 community needs assessment and completing the community action plan (CAP). Tracey reported that the CAP subcommittee convened a meeting last week and created a draft survey as well as a draft plan for collecting public input. The members present provided feedback and approved the materials.

9. Accomplishments/Coordination of Funds Report

Tracey Dickinson explained that the County recently submitted its accomplishments/coordination of funds report. The board reviewed the report.

10. Oroville Dam Evacuation Emergency Shelter

Tracey Dickinson updated the board on the County's recent efforts to open an emergency shelter for Oroville Dam evacuees. Vince Olvera asked why residents did not receive notification that the County opened a shelter and needed assistance. Tracey explained that since the shelter was only open for a few nights, the County was unsure about what help and resources it needed. Tracey encouraged all members to sign up for the County's emergency notification system called Everbridge.
