### COMMUNITY HEALTH BRANCH UPDATES

#### **EMERGENCY SERVICES**

On March 29 and 30, the Emergency Services Infectious Diseases Unit of the Community Health Branch hosted an ICS 400 Advanced ICS for Command and General staff training course. This multi-faceted course provided advanced training of the Incident Command System and facilitated exercises that dealt with the special



management challenges in a major incident, area command establishment and multi-agency coordination system. The training group was very interactive and had multi-disciplinary participants from Yolo and surrounding counties. This wide range of participants allowed networking and partnership opportunities to better prepare Yolo County in an emergency. Participants included California Corrections, Wheatland Fire Department, Yocha Dehe Fire Department, UC Davis Fire department, Sacramento City Fire Department, Sacramento County Environmental Health and Epidemiology, California Highway Patrol, Kaiser South Hospital, Yuba County Emergency Preparedness, Solano County Public Health Nurse, National Guard, Yolo County Sheriffs and AMR

### INFECTIOUS DISEASE

On March 6, 2017 the California Tuberculosis Controllers Association (CTCA) Executive Committee voted to add HHSA Senior Public Health Nurse Katie Kelsch as the new representative from small and rural counties beginning July 1, 2017. CTCA is the association for Tuberculosis controllers, program managers and clinicians. CTCA partners closely with the California Department of Public Health Tuberculosis Control Branch to advocate and develop guidelines for the management and treatment of Tuberculosis. Katie Kelsch will serve on this committee to ensure that the voice and needs of small and rural counties are represented.

#### **HEALTH PROMOTION PROGRAMS**

#### **SAFE ROUTES TO SCHOOL**



The Woodland Safe Routes to School program is teaming up with The Bike Campaign on May 5 to host a "Kidical Mass" bike ride in Woodland. This youth-focused ride involves a 3-mile tour that highlights some of the roadway improvements for biking recently completed in Woodland. The event is free and includes an optional bike clinic before the ride to ensure bike safety. See **FLYER** for more information

#### **TOBACCO PREVENTION**

- The Yolo County Anti-tobacco Youth Coalition, with members from Pioneer High School, River City High School, and Woodland High School, joined 300 youth from all over California for Youth Quest. The annual event was hosted by the California Youth Advocacy Network and was held at the State Capitol on March 13, 2017. The youth participated in an educational training in the morning and marched to the capitol to hold a press conference where they informed the public about the dangers of tobacco and electronic smoking devices. Yolo County youth met with staffers from the offices of Assembly Member Aguiar-Curry and Senator Dodd to educate them on the issues surrounding flavored tobacco and electronic smoking devices and to inform them about the activities they are working on in their communities. The youth also invited the Senator and Assembly Member to a "Kick Butts Day" event the coalition is holding at Woodland High School to educate their peers on tobacco issues on March 30, 2017.
- On March 16th, the Tobacco Prevention program co-presented with Supervisor Saylor at the Rural Counties Flavored Tobacco and Menthol Conference. The conference was hosted by the California Tobacco Control Program to provide rural counties with resources and best practices for working with local officials on flavored tobacco policies. The Yolo County presenters were invited to share their recent success with adopting a local policy banning the sale of flavored tobacco. Yolo County was the first community to successfully adopt this type of policy west of the Mississippi.

# MATERNAL, CHILD AND ADOLESCENT HEALTH PERINATAL MENTAL HEALTH

- On March 1, 2017, the findings of the CA Task Force on the Status of Maternal Mental Health were presented at the State Capitol in a White Paper Unveiling briefing. An executive summary was released during the briefing and the full white paper will be available for download on March 18th from www.2020mom.org. Key findings and recommendations were shared by a panel of presenters, including Anna Sutton, Assistant Director of Public Health Nursing and Maternal, Child and Adolescent Health Coordinator for Yolo County. These findings and recommendations highlight, in particular the role that public health can play in strengthening the relationship between communities and health care systems as well as the importance of integrating physical and behavioral health care in the maternity care settings.
- The American Congress of Obstetricians and Gynecology (ACOG) has developed an Expert Work Group (EWG) to write implementation plans and metrics for a set of recommended national standards around addressing maternal mental health disorders in obstetrical settings. Anna Sutton, Assistant Director of Public Health Nursing and Maternal, Child and Adolescent Health Coordinator has been invited to join this national workgroup in a 2 year + project. The group held its first conference call this month and will be meeting in person at ACOG's National Scientific Meeting held in San Diego on May 6-9, 2017.
