

ORDINANCE NO \_\_\_\_\_

**An Ordinance Revising Section 4-5.601 of the Yolo County Code,  
Relating to Storage in Aircraft Hangars**

The Board of Supervisors of the County of Yolo hereby ordains as follows:

**SECTION 1.** The Board of Supervisors of the County of Yolo, State of California, finds that it is necessary and appropriate to make certain changes to Yolo County Code provisions relating to the storage of vehicles and other non-aeronautical items in aircraft hangars at the Yolo County Airport. The purpose of the changes set forth in this Ordinance is to conform the Yolo County Code to recent Federal Aviation Administration guidance on this issue (81 Fed. Reg. 38906 (June 15, 2016)). Nothing in this Ordinance shall be interpreted to allow the principal use of hangars for purposes that are unrelated to aviation.

**SECTION 2.** Section 4-5.601(a) of the Yolo County Code is hereby amended to read in full as follows:

(a) Non-Aviation storage in a hangar must not interfere with movement of aircraft in or out of the hangar, or impede access to other aeronautical contents of the hangar.

**SECTION 3.** If any section, subsection, sentence, clause or phrase of this Ordinance is held by court of competent jurisdiction to be invalid, such decision shall not affect the remaining portions of this ordinance. The Board of Supervisors hereby declares that it would have adopted this Ordinance and each section, sentence, clause or phrase thereof irrespective of the fact that one or more sections, subsections, sentences, clauses or phrases be declared invalid.

**SECTION 4.** This Ordinance was introduced at a regular meeting of the Board of Supervisors on March 21, 2017, its title read and first reading waived, and then adopted at a second regular meeting held on April 4, 2017. It shall take effect and be in force thirty days following its adoption. Unless a summary of the ordinance was published prior to adoption in accordance with Government Code Section 25124(c), it shall be published once in the Davis Enterprise, a newspaper of general circulation, printed and published in the County of Yolo, with the names of the Board members voting for and against the Ordinance.
