### Notice of Funding for Homeless Services FY 2017 Emergency Solutions Grant

#### OVERVIEW

The State of California Department of Housing and Community Development (HCD) expects to release a Notice of Funding Availability (NOFA) for the Emergency Solutions Grant (ESG) Program in May of 2017. HCD receives funding from the United States Department of Housing and Urban Development (HUD) and the State of California to fund this program. The ESG Program is designed to provide funding for nonprofit providers and local governments to quickly rehouse individuals and families experiencing homelessness while minimizing the trauma and dislocation caused by homelessness.

At this time, HCD has indicated that they have fallen behind on their timeline for releasing the NOFA (which was originally expected in April 2017). However, they do not expect to extend the timeline for local communities to submit the application, which will likely be due in June or early July. They have indicated that there will very few changes from the NOFA that was released in 2016, and local communities should begin their provider selection process based on the 2016 NOFA.

#### REDESIGN OF HCD'S ESG PROGRAM

Over the past two years, HCD has completed a significant redesign its ESG Program. The redesign is intended to invest funds in the most beneficial activities as measured by key performance goals and outcomes.

In the redesigned program, HCD will distribute ESG funding based on Continuum of Care (CoC) Service Areas through two different allocations: (1) Some services areas are approved ESG Administrative Entities that will receive and administer State ESG funds directly, and (2) some service areas will receive funds through the Balance of State (BoS) allocation (described in more detail below).

→ **There are no administrative entities within the HPAC service area, meaning that HPAC will receive funds through the BoS allocation.**

#### BALANCE OF STATE (BOS)ALLOCATION

Funds from the BoS allocation will be made available to each service areas in two ways:

1. **Non-Competitive Rapid Re-Housing Funds:** Each service area will be able to recommend up to two providers for a noncompetitive rapid re-housing grant.
2. **Competitive Regional Competition:** Each service area will be able to recommend up to two projects to compete in a regional competition.

#### ROLE OF HPAC

In the redesigned ESG Program, the local Continuum of Care plays an integral role in recommending provider applications in their service area to compete for funds in the regional competition. Applications shall only be considered by HCD if recommended by the CoC. Each service area must conduct a local competition to select applications. The process must:

- Be fair and open
  - Avoid conflicts of interest in project selection
  - Consider selection criteria consistent with the criteria used by the State
  - Select only eligible activities that are offered consistent with Core Practices, including:
    - Use of coordinated entry
    - Use of Housing First practices
    - Progressive engagement
  - Incorporate performance standards set by the State
  - Consider any other practices promoted or required by HUS
- HPAC will be responsible for designing a local competition that meets the requirements above when determining funding recommendations for the non-competitive rapid re-housing funds and the competitive regional competition.

#### DIFFERENCES BETWEEN FUNDING OPTIONS

<b>Submittal Requirements</b>	CoC must notify HCD of which providers are selection by July 5, 2017. Providers are not required to submit a completed application to HCD. Instead, the CoC may determine its own application and selection process	One hardcopy application with wet signatures and one compact disc or USB flash drive copy (with signatures) must be received by express mail carrier via overnight delivery by the application deadline of Friday, July 5, 2017 at 5pm

<b>May 12, 2017</b>	Notice of Local Funding Availability released to public
<b>May 18, 2017</b>	HPAC ESG Meeting to Discuss Grant Timeline and Selection Process- 8:30-9:30am
<b>May 24, 2017</b>	Local Competition Timeline and Selection Process adopted by HPAC (via email vote)
<b>May 24, 2016</b>	Mandatory Notice of Intent to Apply due from applicants
<b>May 31, 2017</b>	Letter of Application for Non-Competitive Rapid Re-Housing (NC-RR) due from applicants
<b>June 7, 2017</b>	Application for Competitive Regional Funds (CR) Due for Applicants
<b>June 12-16, 2016</b>	Members of the Selection Subcommittee review and rank all applications (for both CR and NC-RR funding pools) independently
<b>June 22, 2016</b>	Selection Subcommittee meets to develop funding recommendation
<b>June 28, 2017</b>	Selection Subcommittee presents funding recommendations to HPAC at meeting of the full body; HPAC votes to determine projects that will be submitted to the State for funding
<b>July 5, 2017</b>	Applicants (who were selected by HPAC) submit finalized applications to State
<b>July 5, 2017</b>	Homeless Coordinator submits required supplemental documents to State
