- **5.** MCAH DIRECTOR'S REPORT Anna Sutton
  - MCAH Director: Anna Sutton is currently the interim MCAH Director; however Anna will be keeping the MCAH Director role. A new Community Health Branch Director has been hired; Mimi Hall will start on July 24<sup>th</sup>.
  - CalFresh: Katya Lopez shared that CalFresh recently attended a state-wide call center collaborative, where information on new technologies and systems were shared. These new resources will help with the flow of services, which will also help Medi-Cal services.
  - **Norovirus:** Now that school is out for the summer, data on Norovirus is no longer being collected. The CD team is working with summer schools, camps, and child care centers in the event the outbreak has a resurgence.   - Safe & Social Training: Ramy Husseini shared that the Safe & Social Training will be offered as an ongoing class. Once the dates are finalized, Ramy will share that information.
  - **CPSP Roundtable:** Monica Koenig shared that there were about 35 attendees at the CPSP Roundtable in May. A need for more resources for families with Zika was identified.
  - **FIMR:** Monica Koenig shared that moving forward there will be two teams for FIMR; the Case Review Team (CRT) which will continue to review cases and the Community Action Team (CAT) which will develop action items around the themes identified in the CRT meetings.
  - Nurse Home Visiting: Due to lost funding, the AFLP program is being modified and rolling over to MCAH. The new program, Adolescent Parenting Program (APP) will serve up to 30 pregnant and parenting youth up to

- age 19. The team is working on revising screening tools and visit schedules. AFLP clients will be transferred over and outreach will begin in July.
- Farmers Market Vouchers: Laurie Somerhausen shared that WIC is now issuing Farmers Market coupons. In addition, the Woodland Farmers Market and the West Sacramento Farmers Market that takes place on the river will accept the year round WIC fruit and vegetable vouchers.   - The Sac LGBT Community center also provides trainings such as LGBT 101, which can be personalized to the
    audience The goal of these trainings are to educate individuals on providing culturally appropriate services,
    as well as collecting data in a respectful way.
