STEPS TO SUCCESS PROJECT SUMMARY

Background

In November 2016, **the Board of State and Community Corrections** released a funding announcement for the Proposition 47 Grant Program. Using cost savings generated by the 2014 voter-approved initiative, the purpose of the grant is to provide mental health services, substance use disorder treatment, and misdemeanor division programs for persons involved with the criminal justice system.

In March 2017, the Yolo County Health and Human Services Agency, in partnership with the District Attorney's Office, Probation Department, and Public Defender's Office, submitted an application to expand Yolo County's existing continuum of criminal justice diversion programs. Specifically, the project proposed to apply the principles of restorative justice and trauma-informed care to provide wraparound services to individuals that are eligible for a diversion program, but are unlikely to succeed without intensive supports due to their history and current issues with mental health and/or substance use disorders.

On June 8, 2017 the BSCC Board awarded HHSA **\$5,968,215** in funding for a 38-month project, which equates to approximately \$1,884,699 annually.

Target Population

The project's target population is persons who:

- 1. Have been arrested, charged with, or convicted of a criminal offense;
- 2. Are currently eligible for a diversion program in Yolo County; and
- 3. Have a history of mental health issues and/or substance use disorders.

Project Goal

The project proposes to reduce recidivism and advance the recovery of people in the target population by improving four key areas in the lives of each participant, including:

- 1. Criminal justice involvement;
- 2. Housing stability;
- 3. Behavioral and physical health; and
- 4. Self-sufficiency.

Project Description

The project's components include:

- 1. Outreach and assessment;
- 2. Criminal justice diversion;
- 3. Intensive case management and treatment;
- 4. Civil legal services; and
- 5. Permanent housing assistance.

STEPS TO SUCCESS PROJECT SUMMARY

1. Outreach and Assessment

The project's outreach and assessment step will feature two Clinicians and one Probation Officer. Working in collaboration with local law enforcement agencies, the team will conduct outreach to locate and engage potential participants.

Once staff identifies a participant and the DA's Office verifies his or her eligibility for diversion, the team will administer a series of assessments to determine risk of recidivism, mental health and substance use disorder diagnoses, as well as level of vulnerability.

2. Criminal Justice Diversion

Individuals deemed eligible and approved by the DA's Office will be offered the opportunity to participate in the diversion program best suited for their individual needs. If a participant chooses to opt-in, he or she will work with the existing diversion team to address their criminal offenses and become connected to the services described in the following steps.

3. Intensive Case Management and Treatment

Once admitted to a diversion program, participants will be connected with the case management and treatment step of the project. Utilizing one Clinical Program Manager, one Clinician, and two Case Managers, the team will create and implement case plans for each participant.

4. Civil Legal Services (optional)

In addition to the criminal legal issues being addressed by the DA's Office, some participants may have civil legal problems. Participants with these issues will be connected with the civil legal services step of the project for legal assistance. The civil legal services will include helping participants address any non-criminal barriers to accessing basic necessities such as healthcare, housing, government benefits, and employment. To encourage self-sufficiency, this step will also offer "know your rights" educational sessions.

5. Permanent Housing Assistance (optional)

Participants who are unstably housed or experiencing homelessness will be connected with the permanent housing assistance step of the project. Utilizing a rapid rehousing model, participants will be offered rental subsidies, for a period of no more than 24 months. Participants may also be offered financial assistance with paying deposits and/or utility bills to secure permanent housing and purchasing needed household items when moving into new housing.
