Meeting brought to order by Ginger Hashimoto at 4:35 p.m.

#### 1. Pledge of Allegiance

Ginger Hashimoto led members in the Pledge of Allegiance.

## 2. Introductions

Ginger Hashimoto led members in introductions. The board welcomed the meeting's presenter, Karen Larsen, Yolo County Health and Human Services Agency Director as well as new member, Elizabeth Mosley.

## 3. Public Comments

Members did not have any public comment.

## 4. Approval of 9/12/17 Agenda

The board approved the agenda with no amendments.

## 5. Approval of 4/11/17, 5/9/17, 6/13/17, and 8/8/17 Minutes

The board approve the April, May, June, and August minutes with no amendments.

## 6. Health and Human Services Agency Presentation

Karen Larsen provided an overview of the County's agency. She explained that in 2015 the County integrated its social services programs to establish one Health and Human Services Agency. Creating a "no wrong door" approach, the County merged its Department of Employment and Social Services, Department of Alcohol, Drug, and Mental Health, and Public Health

Department and converted its organizational structure to reflect the populations served—Adult and Aging; Child, Youth and Family; Community Health; and Service Centers. Karen acknowledged that while the integration was challenging, the result of such reorganization eliminates the need for clients to navigate multiple systems and allows for the efficient and seamless provision of appropriate services no matter where the clients enters.

#### 7. Election

Ginger Hashimoto explained that the board's chair position has been vacant since Helen Voss resigned in May. Despite trying, the board was unable to elect a new chair without a quorum. Since a quorum was present, the board accepted nominations and elected Isaac Blackstock as its new chair.

#### 8. Organizational Standards Update

Ginger Hashimoto reminded members that staff completed its organizational standard review in August. The State has since approved the review. As opposed to last year, CSAB does not have a corrective action plan. Nonetheless, Ginger underscored that CSAB should continue to strive for improvement, particularly in its efforts to engage and involve low-income persons.

#### 9. Review Draft Request for Proposal

As a conflicted member, Bill Pride excused himself from this agenda item. Ginger Hashimoto led the remaining members in reviewing the draft request for proposal. Members revised several areas including clarifying the scope of work and editing the minimum as well as preferred qualifications. Members approved the draft with the recommended changes.
