Qualified Professional – for Site Evaluations/Soil Profiles only = An individual licensed or certified by the State of CA and who has been approved by DEH to perform Site Evaluations and to practice as an expert as allowed under their license or registration and as demonstrated by their possession of knowledge and skills of soils and system siting design and installation. Depending on the work to be performed and various licensing and registration requirements within the provisions of the CA Business & Professions Code, this shall include an individual with one or more of the following credentials: CA Certified Engineering Geologist, CA Registered Professional Engineer, CA Registered Environmental Health Specialist (REHS), CA Registered Geologist (RG), Soil Scientists certified by the Soil Science Society of America.

Qualified System Designer – For the Design of Septic Systems = A person who possesses knowledge, skills, and experience in system design and who is qualified to perform civil engineering in accordance with the Business and Professions Code; or who is licensed as a CA REHS. (For more information, please see the Yolo County OWTS Manual). Note: a gravity/standard septic system can be designed by an approved licensed septic contractor, and an alternative septic system shall be designed by an approved qualified system designer.
