- Karen reviewed the results from the 2017 Provider Stakeholder Survey that was sent out in December.
- Increased participation feedback:
 - Providers leading different meetings could increase attendance.
 - Include a call for agenda items from agencies.
 - Limit provider presentations to new agency and by request only with a time limit.
 - Some folks like HHSA staff in attendance to answer questions.
 - o Detailed agenda to help identify mandatory vs nice to know meetings.
 - Shorter mtg time (typically 1 hour this one longer due to agenda)
 - Doodle poll for new date /time options
- Current agenda items feedback:
 - Keep HHSA Director's updates, preferably at the beginning and tailored to those in attendance.
 - Timing around communication of topics is important.
- New topics feedback:
 - Performance measures are being built into contracts, it would be nice to highlight what is new in contracts, performance management and reviewing data when available.
 - Annual Cost Reports training geared towards providers, as well as providing technical assistance.
- Frequency feedback:
 - Monthly if relevant and useful.
 - Detailed agenda like today's is helpful.

 HHSA is in the process of opening a Mental Health Urgent Care in West Sacramento at 500 Jefferson Blvd. It will likely be a phased implementation that will included extended hours and days. A press release will go out when the facility is open.
