- 6. COUNTY REPORT Supervisor Jim Provenza has formed the ad hoc Willowbank Waste Management Advisory Committee to obtain input on neighborhood concerns and preferences for garbage and organic waste removal services upon the June 30, 2019 termination of the County's current agreement with Davis Waste Removal. Union Pacific Railroad has petitioned the California Public Utilities Commission to close the I-80 freeway frontage road east of Davis (County Road 32A) because of safety concerns involving its nearby railroad crossing. Supervisor Jim Provenza has expressed his concerns about the ramifications of closing the road, including the traffic impacts on Chiles Road and South Davis. The County Board of Supervisors continues to review the County's approach to various issues regarding medical and recreational cannabis crops, nurseries and processing activities, including its taxation and zoning.
- 7. MACE BOULEVARD AND MONTGOMERY AVENUE INTERSECTION The City of Davis has agreed to install a three-way stop sign at the intersection next month. This development was facilitated by Supervisor Jim Provenza during his "2-by-2" meeting with Davis Councilmember Lucas Frerichs in mid-October.
- **8. MACE BOULEVARD "ROAD DIET" PROJECT.** In the coming months the City of Davis will reduce the existing four traffic lanes to two lanes on Mace Boulevard between Cowell Avenue and Blue Oak Place in order to construct enhanced protections for bicyclists and pedestrians.

9. WILLOWBANK SOIL TYPES, STORM DRAINAGE, DRIVEWAYS AND FLOOD CONTROL – Following up on an inquiry made at the Committee's meeting on September 28, 2017, the County has prepared some materials for our review on local soil types, storm drainage, driveways and flood control.
