1. Call to Order and Introductions
  - a. Shawn Kinney, EMCC Chair called the meeting to order at 8:36am roundtable introductions followed.
2. Approval of Agenda & Minutes
  - a. Barry Burns moved to approve the Minutes from July 20, 2017, and the Agenda for September 21, 2017. Vinnie Ryan seconded the motion and the motion carried.
3. Update: EMCC Membership, Karisa Huie
  - a. There have been no EMCC Membership changes since the last EMCC meeting.
4. Report: Health Council (HC), Scott Gowin reported:
  - a. The August & September Health Councils were cancelled. However Scott Gowin contacted the Yolo County Landfill, Marissa Juhler and found that if you are collecting less than 220 lbs. of Sharps a month you can take them to the Household Hazardous Waste Facility at the Yolo County Landfill for a nominal application and disposal fee. Sharps still need to be placed in puncture-proof and break-resistant containers for safety and marked "Sharps". Please check the Yolo County Landfill website for current drop-off days and times or by calling 800-207-8222. This information will be shared at the next Health Council meeting in October.
  - b. West Sacramento Fire Department (WSFD) has also contacted the Yolo County Landfill. They have received a fifty-five (55) gallon drum for sharps disposal and the Landfill will come and empty it for a \$150.00 each time. WSFD anticipates having to have it emptied maybe twice a year.

  - a. Discussion was asked to be tabled until next EMCC meeting and then to have Scott Hatcher and Kristin Weivoda present on the subject.
6. Report: EMCC Subcommittees
  - a. **Contractual Compliance Subcommittee (CCS) & Penalty Funds Subcommittee (PFS):**  
The next meeting for both subcommittees will be a combined meeting on October 25<sup>th</sup> at 10:00am, in the Walker Room at 137 N Cottonwood St., Woodland. Please bring your contract changes and ideas for penalty funds purchases.

7. Report: YEMSA, Kristin Weivoda reported:
  - a. Overview of YEMSA PowerPoint presentation: (presentation available upon request)
    1. Contractual Compliance: Countywide Second Quarter June-July 2017: 3,746 responses, 190 delayed, 95% Compliance.
    2. Penalties Collected for March 2017–July 2017 = \$146,950.00
    3. Penalty Projects:
      - i. Sustaining Projects: PulsePoint, Mind Flash, Go Animate, CodeSTAT, YEMSA App, AHA/ITLS, Misc. EMS Forms, EMD-Q Program (YECA), & Medical Director
      - ii. New Projects: UCD Partnership EMS Training
    4. Fiscal Report: Fiscal Year (FY) 17/18
      - i. Kristin meeting with Fiscal was cancelled so there are no updates on overhead issues to share at this time.
    5. Incident & Occurrence Summary Reports: July = 1, August = 2, September = 1.
    6. FIRSTWATCH: The proposal goes to the Yolo County Board of Supervisors on October 10, 2017 for final approval. Programming will take six to eight months to get up and running.
    7. ReddiNet is in the final approval process with Fiscal on purchasing the software. Our go live date is planned for January 2018.
    8. Homeland Security Grant purchases: We are working with our Fiscal unit to purchase 50-65 Rescue Task Force Kits
    9. YECA – EMD-Q: In first phase reviewing select call types starting with July and August Cardiac Arrest Calls.
    10. New EMT Regulations Update: Hands-on & Online trainings have been developed for the new EMT Regulations; for Narcan & Epi-IM Administration, and Glucose finger stick. Training for these new regulations must be completed by December 2018. YEMSA is in the process of creating new protocols for said regulations that will be released January 1<sup>st</sup>, 2018.
    11. Naloxone Distribution Project: State executed contract on September 19, 2017 and we are now awaiting our shipment of Narcan.
    12. Key Activities: Ambulance Inspections, West Sacramento Police & Yolo County Employee CPR & AED Training, Public Health Accreditation Board site visit, CQI Trauma Advisory Committee, Physician Advisory Committee, Paramedic Orientations, Statewide Exercise Planning, EMS Yearly Report, Protocol Review, TXA/Hemorrhagic Shock Trial Study Training & Planning, CARES (live), Transition to Reddinet, Case Reviews.
