- 5. PUBLIC COMMENT

- 6. <u>COMMUNITY HEALTH BRANCH REPORT MCAH HIGHLIGHTS</u> Anna Sutton
 - Mimi Hall, MSP: Community Health Branch Director
 - CMSP is the County Medical Services Program; this is used to cover the medically indigent adults in the county
 - 35 counties throughout California participate in CMSP; there is a governing body; each county puts money into this
 - There is currently no one on CMSP. This due to the ACA (Affordable Care Act) changing and expanding so that childless adults may receive Medi-Cal. This is one factor that has caused reduced CMSP numbers
 - The CMSP governing board took a look at who is isn't covered; those who are covered are those that are undocumented and those who are in primary care. They've made a change to add preventative care and prescription drugs. People are still not enrolling in CMSP for a multitude of reasons.
 - Yolo County Administrator Patrick Blacklock is now a part of the CMSP governing board; he is taking a look at what the challenges are to CMSP

- Anna Sutton: MCAH Director, Director of Public Health Nursing
 - Our Infectious Disease Unit, most recently spent much of its time mitigating the effects of flu season. A new website was launched for the flu that includes resources of the community on ways to prevent it and what do to if infected. Flu season is now slowing down and coming to an end.
 - MCAH core Programs have been doing a lot of work with Maternal Mental Health and Adolescent Health
 - EMS-Emergency Medical Services has launched a new system of communications
- Lizeth Betancourt Shared that it is WIC's one-year anniversary working with Progress House. WIC sends a breastfeeding counselor to Progress House and they offer a breastfeeding support group. Participants are offered a variety of WIC resources and are able to follow up with their WIC appointments. WIC also provides them with breast pumps.

- Questions asked in the table top exercise included; What are the overarching issues that you feel are the most important to your target population? What barriers/challenges stand in the way of decreasing those health disparities that you just identified? What local opportunities or partnerships (CBO, governmental, private) could your organization leverage to address these issues? What vulnerable groups are we missing / not being reached? What innovative strategies do you suggest to reach these populations? What types of resources/assistance could Yolo MCAH provide your agency to support your scope of work?
- After looking at everyone's feedback a group of shared concerns were identified. The shared issues included obesity, access to school based health services, cannabis, opioids, mental health services, the need to reach rural communities, and preconception education.
- Specifically for the Prenatal Group was Nurse Home Visitation services
- The 0-5 age group identified a need technical assistance around children with special health care needs
- The 5-14 age group uniquely identified dental care and access to nutrition health, sexual health, and access to STD testing
- Group leads from each population group should take this opportunity to drill into what data they want in order to understand the issues more thoroughly. We can also identify what data gaps there are.
- We can use the first meeting assigned to each age group to go over data and the second meeting we can bring subject matter experts to help address the gaps identified by the data or have a brainstorming session to see how we can gather missing data
- Ramy can assist in sending out the data to all group leads
- Group leads will need to request the data at least two weeks in advance
- If the group leads have a contact person in mind to present, the group lead can contact the person to come present
