1. INTRODUCTIONS AND PROGRAM UPDATES

2. DIRECTORS REPORT-

Last month's MH directors report was sent as an attachment

- **MEDICATION ASSISTED TREATMENT (MAT)**-Working on getting in West Sacramento. Operated by Core Medical Services who already serve YC in Sacramento Part of DMC-ODS
- **YOLO COUNTY ASSERTIVE OUTPATIENT TREATMENT (AOT)**-Laura's Law update to BOS last month. Client Outcomes and Cost Benefit Analysis
- **EXTERNAL QUALITY REVIEW ORGANIZATION (EQRO)**-Annual review complete, thank you for participating in last month's conversation. Things went well. The report will be sent soon with areas for improvement
- **RFP Release Calendar**
 - **Ian**-SUD RFP was issued. Condensed more than a dozen contracts. Now one RFP will be issued for all services in the SUD continuum of services. Eleven different scopes are included. Looking for responses that apply to each individual scope to create whole continuum. Residential, withdrawal, etc. Tuesday the fiscal plan from DHCS was approved. Still looking to go live July 1st. SUD services for adults will be more comprehensive with more services in July.
 - **Matt**-Rethinking how we do CWS, traditionally incident focused instead of behavioral change. Thought how to build services through building protective capacity. Combined multiple contracts into one single RFP. Looking for creative trauma informed, evidence based services. (Handout)
 - **Kim**-One big RFP integrated model. Different scopes-outpatient to wrap services. (Handout)

Bidder's conference will be held for those RFP's

For providers-there will be a lot coming out for RFP. 3 year contracts, many things coming up for bid again as well as changes in the way of issuing. Hoping it streamlines it for providers. RFP's have extended time they are open, sometimes 6 weeks or more depending on the item. Some RFP's will overlap. A Bidder's Conference will be held for every RFP released. Make sure to attend and that you are in BidSync.

A draft RFP schedule was shared.

- HHSa will be providing an update on the RFP and contracting process in March. This RFP schedule will be posted online and be kept on the PSWG agenda as a standing item

- **TRIENNIAL**-State here for Triennial. Reviewing system side with random chart audit (10 children and 10 adult). Last time, disallowance was 67% (did not meet muster) have to pay back money. This year, the system side added 100 measures and achieved 97% compliance. Chart review-preliminary between 90-95% in compliance.
- **MHUC**-Open House scheduled for April 4th beginning with Ribbon Cutting Ceremony at 8:30am. Located at 500B Jefferson Blvd., West Sacramento. The MHUC is open 7 days a week, 12-9 pm. If you would like a tour or brochures, please connect with Harjit. Currently averaging 2 people per day to start. Open to any Yolo county resident, not just West Sacramento. Christina will send out flyer/save the date invitation.
- **SB-82**-Changing the way its administered. 2RFP's were issued (TAY/Adults, Children). Yolo County is applying for both. Goal is to have 4 staff to respond to TAY and Children in the County. The 3rd grant is school/county partnership that is still in the works of deciding to apply.
- **DATA**-Inpatient hospitalization data was previously provided. If you have questions, please reach out to Karen. Trying to give data reports on monthly basis.

Tuesday-presentation at BOS on procurement policies. Last March a robust discussion around RFP and contracting process. Want to ensure a competitive process and best value. Will be updating the BOS about the changes, like RFPs open longer time, less overlap, bidder conferences, to make things easier for providers and ensure high quality services.

We issued RFP for CIP type services (after hour's access line and crisis response). We are in the process of awarding to Heritage Oaks. Exciting new partnership – excited to have after hour's response. Goal is to have 24/7 crisis response capabilities within the county.

CIT issued to Mike Summers for law enforcement trainings.

3. **CCP STRATEGIC PLAN**-Consists of seven voting members: Karen Larsen, Sheriff, DA, PD, Court, Probation, and Police Chief (Rotating). Patrick attends. BOS. Public and Providers are also welcome. Created 3 years ago and accomplished most but still need to update since AB109-like Prop 47, etc. The Strategic Plan will be updated and they want Providers and Stakeholders to have a say in the next year's plan.

Karen asked providers if there were any items they would like to see in SP that relates to the CCP Strategic plan Goals.

Goal 3: what does that look like? Programs in funded under that goal historically have been tied to PD, Probations, and etc. arrest conviction charging policies. Working on – counties strategic plan has an item around continuum of care around those in the criminal justice process. Many meetings around that are to develop the continuum. Those subgroups have focused on decreasing those with MH in custody, gaps in current system, and strategies for back filling.
