# Potential Policy Changes

---

## 1. Data

- ❖ Compile full list of CCP funded programs. Create list of program and criminal justice data to be collected starting in the next fiscal year.
- ❖ Create a repository of important CCP documents that will act as a central location for CCP members to be able to get ahold of information easily (possibly as a shared drive).

## 2. Public Communications

- ❖ Work to make the public-facing website have more information for the public and be more easy to use.
- ❖ Start brainstorming what social media content should look like.

# Potential Policy Changes (Continued)

---

## 1. Measuring Progress Going Forward

- ❖ Develop a method to measure progress on Strategic Plan objectives and program goals.
  
- ❖ Create an annual report that will include:
  - Funds tracking report for CCP programs
  - Strategic Plan Check-In (including updates on objectives and tasks)
  - Criminal justice statistics and analysis for both the state and our County
  - List of programs and associated program data
  - Growth fund estimates from CSAC (with a comparison from last two years and the upcoming year)

# Potential Policy Changes (Continued)

---

## 4. Internal and External Collaboration

- ❖ Work more closely with the Continuum of Care Work Group.
- ❖ Organize a half-day retreat (similar to department retreat).
- ❖ Potentially create a working committee with analysts from departments to work on data collection/analysis, projects, and grant writing.
- ❖ Start formalizing grant writing mechanisms (lead by the CCP Analyst, with technical knowledge and assistance from CCP members).
