9:00 A.M. CALL TO ORDER

1. **WELCOME AND INTRODUCTIONS – Michael Wilkes, Chair**

4. **PUBLIC COMMENT**

- Michael Wilkes acknowledged and congratulated Deborah Ward for stepping in as the new Dean of UCD Nursing School, just until they can permanently fill the position.
- Kathy Brian works at the State Council on Developmental Disabilities, and offered outreach and/or education regarding dealing with people that have intellectual disabilities. Her agency would be happy to help and support however they can.
- Tia Will urged Yolo County residents to carefully read their ballot for the upcoming election regarding District Attorney Candidates and their and position on the issues dealing with mental health and the criminal justice system, and how they interact.

- Michael Wilkes gave a brief overview of the Health in All Policies.

The Council discussed the Health in All Policies, and suggested to add the topic to the June 14th agenda.

5. **STATE AND COUNTY UPDATE** – *Mindi Nunes, CAO's Office*

- **State Budget:** The Governor will release his May revise on May 11th, which is an update to the 2018-19 budget the Governor announced in January.
- **Local Budget:** The Board Facilities sub-committee has decided to offer the opportunity to name the Health & Human Services Agency's Service Centers in both Winters and Davis. A campaign soliciting nominations will be going out in a few weeks.
- **Cannabis Education Coalition:** Dr. Chapman has met with all of the cities in effort to develop an education platform that will be consistent among all communities. Cannabis decisions are made at the local level so the potential exists for each city in the county to have a different approach to cannabis education and outreach. The idea is to have a consistent message so it is more likely to affect change.
- **Measure K:** A tax measure on cannabis is on the ballot for June 5th, and if approved, part of those funds will go towards youth education.

6. **BOARD OF SUPERVISORS UPDATE** – *Assistant Deputy Jessica Jones*

- **Mental Health Month:** HHS is organizing numerous events this month to recognize and de-stigmatize mental illness.
- **Funding for Psychiatric Services:** The Board approved funds to go to CEP America Psychiatry to provide acute psychiatric inpatient hospital professional services at Dignity Health Woodland Memorial Hospital.
- **Resources for Foster Children:** The Board approved funds to provide an Emergency Child Care Bridge Program for Foster Children (Bridge Program). This program will provide resources and referral services, trauma-informed training for child care providers, and a voucher payment system for child care services for Resource Families/Foster Parents. The Bridge Program is a temporary child care voucher program where services may be provided for up to six months. The goal of temporary child care assistance is to concurrently enroll families in a permanent long term child care program so there is a smooth transition to permanent child care with no break in services.
- **Update on Criminal Justice Continuum of Care:** County staff from the offices of the District Attorney, Public Defender, Sheriff, Probation, Health and Human Services Agency, District 4 Supervisor, and the County Administrator, are working together to improve service provision, prevent recidivism, reduce the number of people with mental illness in the jail system. The group has identified over 50 gaps and needs, have prioritized 16 gaps into their action plan for fiscal year 2018-19.
- **Office of Refugee and Resettlement Grant Program (ORR) Update:** County staff are continuing their work to strengthen the ORR program, and currently working on a package of proposals asking for support to expand staff, the education program and provide mental health support to ORR youth in our care.
- **CommuniCare Navigation:** The Board approved funds to provide the Navigation Center Program services which include: triage assessments and case management to individuals seeking mental health care in Yolo County. This program will assist to reduce and prevent homelessness, involvement in the criminal justice system, psychiatric hospital admissions and length of stays through encouraging individuals to link with care appropriate to their needs.

7. **COMMUNITY HEALTH BRANCH REPORT** – *Steve Jensen, Health Program Manager, HHSA*

- **Maternal, Child and Adolescent Health (MCAH):** In honor of Mental Health Month, the Yolo County Comprehensive Perinatal Services Program will be hosting a Maternal Mental Health brown bag lunch Roundtable on May 24th, from 1-1:30pm in the Community Room at the Gonzales Building.

In October, our Fetal Infant Mortality Review Committee will hold the first Yolo County Memorial service for the families who have suffered a still birth or miscarriage in our community. Additional information will follow.

- **Friday Night Live (FNL):** Winters High School FNL and River City High School FNL are promoting May is Mental Health Awareness month by having students signing a pledge banner that says “Awareness Matters”. There will be a lunch time event at both schools with Mental Health resources available to students.

Pioneer High School and Douglass Middle School has completed the FNL Mentoring program for 2017-18. Twelve high school students mentored 12 middle school students once a week, and have completed 21 sessions. Topics included effects and consequences of using alcohol, tobacco, marijuana, self-esteem, health, friendships, teambuilding and mental health, and many others.

- **Positive Youth Development:** Maternal, Child & Adolescent Health Program Coordinator convened a workgroup focused on a project to address issues surrounding infrastructure for Positive Youth Development in Knights Landing. Positive Youth Development refers to intentional efforts of other youth, adults, communities, government agencies, and schools to provide opportunities for youth to enhance their interests, skills, and abilities. This initiative is the first of its kind to organize various agencies in Knights Landing using a collective impact approach.

8. **HEALTH OFFICER REPORT** – *Mary Ann Limbos, Deputy Health Officer, HHSA*

- **Health Officer Spring Update:** The Health Officer Spring update is in the final stages and will be going out to medical providers and local hospitals soon. Some of the items covered in the update include:
 - HIV prevention and treatments, reminders of importance of screening
 - TB control program
 - Immunizations for the upcoming school year – a reminder for providers to look at the new schedule
 - Flu season summary update for 2017-18
- **Oral Health:** The Oral Health Policy Summit will be on May 18th, invitation only for key stakeholders and elected officials.
- **E. coli Outbreak:** Yolo County has not received any reports, so far, on individuals reporting E. coli sickness.

9. **HEALTH COUNCIL’S BYLAWS** – *Michael Wilkes, Chair*

Michael Wilkes went briefly over the Health Council’s Bylaws, and then asked if anyone had a question.

James Glica-Hernandez pointed out the language needs to be updated reflecting the structure of Health and Human Services Agency; which now includes the Alcohol and Drug department, and the Mental Health department.
