8:30 A.M. CALL TO ORDER

1. **WELCOME AND INTRODUCTIONS** – *Carolyn Campos, Chair*
The May 16, 2018 MCAH Advisory Board meeting was called to order at 8:40 a.m., at which time around the table introductions occurred and quorum was not met.

4. **PUBLIC COMMENT**
 - **Tia Will:** Shared that for the first time since 2006 we have an active competitive race for the position of Yolo County DA. The reason for bringing this up in this meeting, is because whoever we choose as our DA has a lot to do with family, integrity, and our children’s will being. Tia’s ask is that you look at the two platforms for the individual’s running and see who you think best meets your values, vote and talk to other people about it.
5. **COMMUNITY HEALTH BRANCH REPORT – MCAH HIGHLIGHTS** – *Anna Sutton*
 - **Anna Sutton:** Anna shared that we are continuing to actively recruit for the Community Health Branch Director’s position; we are hoping to have someone hired within the next month.
 - **Cindy Martin:** shared that DESS is waiting to see what impact the Executive Bill the President signed will affect the services provided; there is still no CMPS numbers; they are still short staffed; they are almost 80% compliant with their applications; the wait time of the call center is 30 minutes, asking people to be patient when they call and not to hang up; DESS was approved to have extra help workers; those extra help will then fill those vacant positions; because of the limitations on staff, if the public comes in wanting to speak to someone they may not be able to and will be referred back to the phone system. Looking into a new phone system, this phone system will have a call back capability, hoping that it will be up in running within the next year. The phone wait time is longer, but when clients call they are taking care of everything the client needs help with instead of referring them to another person; also there is a website clients can go to <https://www.mybenefitscalwin.org/> and they can create their own account, give updates and upload documents without having to come into the office; clients can come into either office location and use the computers the employment center computers.
 - **Monica Koenig:** Because May is Mental Health Month, we will be holding a Maternal Mental Health Round Table for the Comprehensive Perinatal Services Program; we will have a panelist discussion, around the issue and services that are available in our county; it is free and will be held on May 24th, the Community Room which is located in the Gonzales Building; Anna will be speaking, someone from CommuniCare, someone from Partnership, and someone from our new

urgent care center. For FIMR will be holding our first memorial services for families that have lost a child due to a stillbirth or miscarriage; it will be a butterfly release at the Davis Arboretum. Our SIDS program is creating an educational module with Chico State University; it'll be a 10 min module and we're hoping to roll it out with WIC; we've partnered with Cribs for kids for play pens once the families watch then we can offer them a free play pen. They play pen comes with a sleep set, a pacifier, and hoping this will roll out in October which is SIDS awareness month

- **Willy Onate:** Step by step will be moving from the Bauer building to the Gonzales Building with in the next two days
- **Raquel Aguilar:** the nurses have been working hard to keep are communities connected with their providers by working with Medi-Cal. Sometimes the families have a change in income and both the Nurses and CHA's have been working hard to ensure that these families don't lost their health care coverage; also we are starting to plan our Community Baby Shower, this will be the third one.
- **Laurie Somerhausen:** WIC has walks in every Tuesday from 2:00-4:00; have requested to state to have a mobile site; summer 2019 - April 2020 WIC will be on an electronic card.
