### Emergency Medical Services Agency

- Yolo County Emergency Medical Service Agency has received the American Heart Association's Mission: Lifeline® EMS Gold Award for implementing quality improvement measures for the treatment of patients who experience severe heart attacks for the second year. Yolo County Emergency Medical Services Agency is one (1) of five (5) of the California Local Emergency Medical Service Agencies who have achieved recognition at the Gold Level. Emergency Medical System providers are vital to the success of Mission: Lifeline. EMS agencies perform 12-lead ECGs which measure the electrical activity of the heart and can help determine if a heart attack has occurred. They also follow protocols derived from American Heart Association/American College of Cardiology guidelines. These correct tools, training, and practices allow EMS providers to rapidly identify suspected heart attack patients, promptly notify the medical center, and trigger an early response from the awaiting hospital personnel. Agencies that receive the Mission: Lifeline Gold award have demonstrated at least 75 percent compliance for each required achievement measure for two years or more.

### Health Education

- Child Passenger Safety Program – The Child Passenger Safety Program will be hosting the “Get Ready for Summer” Car Seat Checkup Event. This event will be held at the Gonzalez building parking lot Friday, June 15, from 9:30 am to 12:30 pm. Participants will receive a free check up to ensure car seats are installed correctly, check for recalls, and receive additional information on the correct car seat for their child's age, height, and weight. The Office of Traffic Safety funded grant has provided assistance to over 250 Yolo County residents since the grant started in October.
- Pedestrian and Bicycle Safety – The Pedestrian and Bicycle Safety program partnered with the Woodland Safe Routes to School Program and attended Prairie Kermes on May 4<sup>th</sup>. Staff created an obstacle safety course with multiple left and right turns. At this event staff held a safety course where 45 students learned their hand signals and demonstrated them throughout the safety course. Students completed the obstacle while riding a scooter and wore a helmet fitted to their head by staff.

- Tobacco – Staff has been conducting focus groups with middle and high school students to get their thoughts and opinions on flavored tobacco products. In addition we have been conducting key informant interviews this past month with a variety of professionals throughout the county in order to develop additional strategies for working with local communities on flavored tobacco policies.
