1) WELCOME & INTRODUCTIONS

• Emily welcomed the group and around the table introductions were performed.

CHRONIC DISEASE PREVENTION

 Tobacco Retail License (TRL): Steve provided the background on TRLs. Updated data will be available in June.

MENTAL HEALTH

• Consumer Perception: The survey is the same each time but only captures the clients that were seen in the clinic for the identified week.

Providers are counted by contracted agency. In the future, will be able to provide a percentage of providers that participated.

It was suggested that information on what percentage of returned surveys have responses in order to see if there is an improvement overall. One of the determining factors of completed responses is the number of doctors on staff.

EQRO

EQRO is completed annually by a 3rd party to review quality and access to mental health services. Yolo County's review was completed in February and the draft report was received this week. The report identifies high level strengths, areas of improvements and recommendations. One area identified for improvement is the electronic health record and data reporting abilities.

Triannual

Every three years, the Department of Health Care Services (DHCS) performs a Medi-Cal audit on the service delivery system. The preliminary results from that audit show a 97% compliance in system review, which shows that the work on improving the quality of documentation has been successful.

Mental Health Urgent Care

HHSA opened a Mental Health Urgent Care clinic in West Sacramento. Crisis intervention services are available seven days a week from Noon to 9:00 pm. These services are to prevent or minimize use of emergency rooms. The target for this clinic adults with Medi-Cal or uninsured but anyone who walks in the door will be assessed and linked to an ongoing provider. In July, there will also be an afterhours crisis response available.

3) ANNUAL REPORT REVIEW

The group reviewed the 2017 Annual Report and provided edits and feedback.

4) 2019 CHA STATUS UPDATE

- Yolo County HHSA, then the Health Department, completed their first Community Health
 Assessment (CHA) in 2014 as part of the Accreditation process. During that process, there was a
 steering committee made of partners and community members to help guide the process using
 MAPP. This was the first wide assessment of the county. The CHA included multiple
 assessments that were then combined into a full assessment. The CHA helped identify the
 priority areas for the CHIP. The CHA is due every five years.
- Additionally, per ACA, all non-profit hospitals have to completed a Community Health Needs Assessment every 3 years.
- This year, the time frame for the CHA and the CHNA align. HHSA is partnering with Sutter and Dignity to facilitate a joint CHA/CHNA. In addition, CommuniCare and Winters Health Care are part of the steering committee that have been developed.
- The steering committee has combined and refined the Health Status Survey and the Health Care
 Access Survey into a single survey for this assessment period. The survey will be translated into
 Spanish and Russian and is expected to be distributed in May and June. Hard copies of the
 survey in all three languages will be in the HHSA lobbies, as well as available for partners to
 distribute. Electronic copies will also be available in all three languages.
- In addition to the survey, focus groups and town halls will also be completed.
