# MINUTES

The Yolo County Board of Supervisors met on the 2nd day of September, 1997 in regular session in its Chambers in the Erwin Meier Administration Center, Woodland, California at 9:00 A.M. pursuant to County Code Section 2-1.103. All members were present. Chairman Rosenberg presided. Roy Pederson, County Administrator and Charles Mack, County Counsel were present. Undersheriff Tom Musgrove led all in attendance in the Pledge of Allegiance to the Flag.

### Entry No. 1

Approved the agenda for this meeting by consensus of the Board.

### Entry No. 2

Minute Order No. 97-315: Received 1,385 signautres from the Yolo County Veterans Coaliton and adopted and authorized the Chairman to sign <u>Resolution No. 97-111</u> authorizing flying the POW/MIA flag on County property for the next 60 days and thereafter, every holiday and patriotic day appropriate to veterans.
