- D. Authorizes and directs the Community Development Director to act on the County's behalf in requesting formal approval from the State CDBG program to amend Grant No. 96-STBG-1045 to include the incubator feasibility analysis, and if approved, to carry out a competitive procurement process as required by CDBG regulations to select a consultant to recommend to the Board.
