WHEREAS, a petition has been submitted to this Board requesting that proceedings be initiated to establish the Wild Wings County Service Area pursuant to the County Service Area Law (Government Code Sections 25210 and following) and the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 (Government Code Section 56000 and following); and

WHEREAS, said petition describes the boundaries of the proposed county service area, i.e., the subject territory as set forth in Exhibit A, and the services to be provided, i.e., sewer disposal services, sewer collection services, and water services; and

WHEREAS, the formation petition was signed by 100% of the landowners within the subject territory; and

WHEREAS, the petition was reviewed pursuant to the California Environmental Quality Act ("CEQA), and a Categorical Exemption was prepared and approved as the appropriate environmental document pursuant to CEQA; and

WHEREAS, the petition was previously reviewed by the Yolo County Local Agency Formation Commission ("LAFCO") pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000, Government Code Sections 56000 and following; and

WHEREAS, on August 25, 2003, LAFCO conditionally approved the formation petition and adopted LAFCO Resolution No. 2003-11 setting forth that approval, designating this Board as the conducting agency, and setting forth such other matters as described therein; and

WHEREAS, on November 17, 2003, LAFCO Resolution No. 2003-11 approving the formation petition was filed with the Clerk of this Board; and

WHEREAS, on April 6, 2004 this Board adopted Resolution No. 04-55, a Resolution of Intention to Establish the Wild Wings County Service Area, which stated that:

- A. The Wild Wings County Service Area is proposed to be established pursuant to County Service Area Law (Government Code Sections 25210 and following) and the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 (Government Code Section 56000 and following), in the unincorporated area of the County of Yolo set forth in Exhibit "A" attached hereto and made a part hereof.
- B. The name proposed for said county service area is the Wild Wings County Service Area.
- C. The type of extended county services provided by the Wild Wings County Service Area are sewer disposal services, sewer collection services, and water services.
- D. The establishment of the proposed Wild Wings County Service Area is set for public hearing on May 25, 2004, at which time the proposed formation will be considered together with any protests submitted against the public formation.

WHEREAS, the Clerk of the Board of Supervisors published notice of said hearing pursuant to Government Code Section 6061 in the Woodland Daily Democrat, a newspaper of general circulation published in the County, and said publication was completed at least seven days prior to the date of said hearing; and

WHEREAS. said Notice contained the text of Resolution No. 04-55, stated the time and place for the hearing, and stated that at the hearing the testimony of all interested persons or taxpayers for or against the establishment of the proposed Wild Wings County Service Area, the extent of the County Service Area, or the furnishing of the specified types of extended services, would be heard; and

WHEREAS, on May 25, 2004, a public hearing was held to consider the proposed formation of the Wild Wings County Service Area as set forth above; and

WHEREAS, __0__ written protests against the establishment of proposed Wild Wings County Service Area, the extent of the County Service Area, or the furnishing of the specified types of extended services within the County Service Area, were filed with the Clerk of the Board of Supervisors on or before the time fixed for the public hearing, and __o_ protests were made orally at the hearing; and

WHEREAS, <u>0</u> written protests pertaining to the regularity or sufficiency of the proceedings were filed with the Clerk of the Board of Supervisors on or before the time fixed for the hearing, and <u>0</u> protests were made orally at the hearing; and

WHEREAS, at said public hearing the Board of Supervisors was presented with the Categorical Exemption that was previously prepared and approved as the appropriate environmental document pursuant to CEQA, and this Board reviewed and considered the information contained therein; and

WHEREAS, at said hearing this Board also received and considered LAFCO Resolution No. 2003-11, the LAFCO Executive Officer's Report and Recommendations submitted to LAFCO, the Petition Proposing Formation of the Wild Wings County Service Area, the Resolution of Intention, and all other written and oral information presented to the Board in connection with the proposed formation; and

WHEREAS, it appears that there was neither a written protest of 50% or more of the registered voters residing within the territory proposed to be included in the Wild Wings County Service Area nor a written protest by the owners of one-half or more of the value of the land and improvements in the territory proposed to be included in said area as shown by the last equalized assessment roll, against the establishment of the area or the furnishing of a specified type or types of extended service within the area; and

WHEREAS, based upon the foregoing, it appears appropriate to establish and form the Wild Wings County Service Area as described above, without modification of the boundaries or elimination of any of the services specified in the Resolution of Intention;

NOW, THEREFORE, IT IS HEREBY RESOLVED, FOUND, AND ORDERED by the Board of Supervisors of the County of Yolo as follows:

- 1. The foregoing recitals, and each of them, are true and correct.
- 2. All of the proceedings heretofore taken in this matter and all of the proceeding hereinabove recited are valid and in conformity with the requirements of law, including

but not limited to the County Service Area Law (Government Code Sections 25210.1 and following) and the Cortese-Knox Reorganization Act (Government Code Sections 56000 and following).

- 3. The services described in the Resolution of Intention to establish the proposed Wild Wings County Service Area, i.e., sewer disposal services, sewer collection services, and water services, are all and in their entirety extended services.
- 4. There are no written protests against the formation or establishment of the proposed Wild Wings County Service Area that would require abandonment of these proceedings, and this Board determines not to abandon these proceedings.
- There are no written protests that would require modification of the boundaries of the proposed Wild Wings County Service Area, and this Board determines not to modify those boundaries.
- 6. There are no written protests that would require elimination of any of the proposed extended services, i.e., sewer disposal services, sewer collection services, and water services, and this Board determines not to eliminate any of those services.
- 7. The Wild Wings County Service Area is hereby established, without an election.
- 8. The Wild Wings County Service Area will encompass the territory and have the boundaries as set forth in Exhibit A.
- The Wild Wings County Service Area will provide sewer disposal services, sewer collection services, and water services, and it shall not provide any further services without the approval of the Local Agency Formation Commission (LAFCO) and this Board.
- 10. The Clerk of this Board is directed to:
 - A. Mail a certified copy of this Resolution to the chief petitioners and the affected agencies.
 - B. File a certified copy of this Resolution with the Executive Officer of the Yolo County Local Agency Formation Commission.
 - C. File a Notice of Exemption with the County Clerk and provide notice in accordance Section 15062 of the California Environmental Quality Act.

RECOMMENDED ACTIONS

IT IS RECOMMENDED that the Board of Supervisors take the following actions:

- A. **HOLD** a public hearing to consider the formation of the Wild Wings County Service Area (CSA);
- B. CERTIFY that a Categorical Exemption (see Attachment "A") is the appropriate environmental document, having been prepared in accordance with the California Environmental Quality Act (CEQA) and CEQA Guidelines; and
- C. AUTHORIZE the Chair to sign enclosed Resolution (Attachment "B") establishing the Wild Wings County Service Area, determining the boundaries thereof, and designating the services to be performed therein.

FISCAL IMPACT

There will be no impact to the General Fund as a result of these actions. All costs associated with the formation of the Wild Wings County Service Area are paid through a special fund financed by the developer for this purpose. Once the CSA is approved, the County will collect annual revenues from property owners to pay for the water distribution system, sewer collection and treatment system, capital replacement costs for both systems, and administration by County staff.

REASON FOR RECOMMENDED ACTIONS

The proposed formation of the Wild Wings CSA will provide the County with the necessary means to fund and manage the public sewer and water systems that will serve the Wild Wings Development. The CSA will allow the County to fully recover the operation, maintenance, replacement, and administrative costs needed to provide sewer and water services to the

development, as well as establish an Advisory Committee to provide an opportunity for the residents to communicate regularly with the County on issues of interest to the community.

BACKGROUND

The Board of Supervisors adopted the Resolution of Intention to form the Wild Wings County Service Area on April 6, 2004. The adoption of the resolution was the preliminary step required to hold the public hearing on the proposed formation of the district. The public hearing allows interested parties and affected agencies an opportunity to protest or comment on the formation of the CSA.

The Wild Wings Subdivision project area consists of 242+ acres located approximately five miles west of the City of Woodland in unincorporated Yolo County. The Wild Wings Subdivision is planned for 337 single-family homes, a nine-hole privately-owned and operated golf course with a clubhouse and supporting facilities. Supporting facilities will include a maintenance yard; a park and ride lot; bus stop; a recreation area consisting of a swimming pool, cabana/restroom, tot lot, tennis court, and picnic area facility; and an open space access area along Cache Creek. Supporting infrastructure will include the roadway system, water system, sewer disposal system (treatment), sewer collection system, and storm drainage system. The CSA will operate and maintain the water and sewer systems, and collect the revenues to pay for those services, as well as provide for capital replacement costs and administration.

OTHER AGENCY INVOLVEMENT

The Yolo County Local Agency Formation Commission; County Counsel; Wild Wings LLC; Nolte Engineering; McDonough, Holland and Allen; Luhdorff and Scalmanini; Shilts Consultants Inc.; and Harris and Associates have been involved in the proposed CSA formation.



COUNTY SERVICE AREA THE WILD WINGS COMMUNITY PROPOSED BOUNDARY


