- 4. Presentation about flash incarceration probationary programs (Cardall/Fruchtenicht) -

As discussed in previous meetings, Chief Cardall would like to move forward with implementing Flash Incarceration. This is an important tool that can achieve success in some individuals. Assistant Chief, Dan Fruchtenicht presented a PowerPoint presentation along with each member receiving a handout explaining the process. The group will form a subcommittee to work on the project. Dan will contact various stakeholders in the near future to schedule a meeting.

8. CCP Strategic Planning Workshop – Analyzing CCP 2014 – 2019 Strategic Plan Objectives (Blacklock)

Chief Administrative Officer, Pat Blacklock presented the Strategic Plan Revise Workshop. All members received handout of PowerPoint presentation. Our main goal as of today will be to cover our current plan objectives and collect new objectives moving forward in the plan.

The CCP Analyst, Jesse Hoskins and the Assistant Chief Probation Officer, Dan Fruchtenicht, acting as representatives for the Chair of the CCP, held meetings with each individual CCP member to discuss both general feedback on the CCP, as well as discuss objectives from the 2014 – 2019 Strategic Plan.

Based on the analysis of all the CCP members, staff compiled 32 objectives from the CCP 2014 – 2019 Strategic Plan into four categories as follows:

- Objectives that are Discrete and Completed
- Completed Objectives with Identified Next Step
- Ongoing Objectives
- Objectives that Need Reconsideration or Not Completed

All 32 objectives were reviewed by the CCP members. Of the 32 objectives listed in the Strategic Plan, 21 objectives were retired. Of these 21 objectives, 12 were considered to be completed and 9 were either incorporated into new potential objectives or considered no longer relevant. At the August CCP meeting, the group will conduct another workshop in order to set out the objectives in the Strategic Plan Revise, as well as establish leads on the decided objectives.

Next, Mr. Blacklock covered areas of Proposed Mission/Purpose and Revised Goals. We will cover our new suggested objectives are our August meeting.
