Meeting was brought to order by Isaac Blackstock at 4:38pm. Quorum established with 8 members present.

2. Introductions and Community Updates

Isaac Blackstock led members in introductions and Community Updates.

- Isaac Blackstock reported that his Lead Client Navigator position with Yolo County Housing was now permanent.
- Emily Meza informed the group of a scheduling conflict for the presenters from Yolo County Children's Alliance and that they requested to present earlier.

6. AMENDED ORDER: Provider Presentation: Erin McEwen, Yolo County Children's Alliance Erin McEwen from the Yolo County Children's Alliance presented on their Housing Navigation program funded by CSBG. Reference the attached PowerPoint presentation for complete details. Presentation highlights include:

- Erin commended Yolo County HHSA CalWORKs program for working quickly to help families that present to her office as homeless or at risk of homelessness.
- She also commended Yolo County Housing for being a close collaborator.
- Based on her observation of clients, she stated that the majority of recently homeless in West Sacramento are individuals who community members being displaced from homes where they have lived for years.
- YCCA utilizes the VIA system implemented by the City of West Sacramento which acts as a low-cost transportation system for seniors in a model similar to ride-sharing apps such as Uber or Lyft.
- Erin's discussion of challenges that homeless individuals and families face included noting
 the high costs of the many motels/hotels in West Sacramento, that are often the only
 housing option for individuals. Roz Stone asked if anyone has considered purchasing the
 motels/hotels and Erin responded that yes, various public entities have looked into it but
 ultimately it was unfeasible.
- Vincent Olvera asked why YCCA targets West Sacramento and it was explained that there was a service gap in West Sacramento prior to their program, whereas the other two major cities in Yolo County have more of a homeless/housing navigation infrastructure.
- Maria Chairez commented that the 2-hour bus ride from West Sacramento to Woodland for clients to receive essential services at providers such as Fourth and Hope and Legal Services of Northern California was excessive.
- Jeneba Lahai from Yolo County Children's Alliance ended the presentation by urging those present to talk to their local politicians to advocate for housing and homeless resources in Yolo County.

7. Legislative Policy Presentation

Chris Martin, Homeless Policy Advocate from Housing California, provided the group with an overview of Housing California sponsored legislation and information related to the new funding sources wrapped up in the CA State Budget.

Topics covered included:

- SB 918 (Wiener) Homeless Youth Act of 2018
- SB 1010 (Beall) Supportive Housing Pilot Program
- AB 2161 (Chiu) Homeless Integrated Data Warehouse
- AB 2162 Streamlining Supportive Housing
- Homeless Emergency Aid Block Grant \$500 million total
- Department of Social Services funding for CalWORKs Housing Support Program, CalWORKs Homeless Assistance Program, and Senior Home Safe Program

- Office of Emergency Services funding for Domestic Violence Shelter Program and Homeless Youth and Exploitation Program
- Department of Health Care Services funding for Homelessness and Mental Illness Program
- Homeless Coordinating and Financing Council now has paid staff
- SB2 funding utilization
