The Yolo County Library issued a Draft Environmental Impact Report (EIR) for the New Yolo County Library Building Project on July 20, 2018.

## The existing Yolo Branch Library:

- Is the oldest (almost 100 years) and smallest library building in the County library system
- Is a historical resource listed on the National Register of Historic Places and California Register of Historical Resources
- Has significant structural deficiencies and other fire and life safety, plumbing, electrical, roofing, and deferred maintenance issues.




#### The project is intended to:

- Eliminate existing building's structural and other issues (i.e., provide a permanent library facility)
- Provide a new, larger library that:
  - Has programming flexibility
  - Expands book and media collections
  - Improves services / operating goals
  - Can be operated by limited staff
- Provide a meeting room / other space that supports the library's use as a community gathering place
- Retain the look, feel, character, and history of the site and Town – to "link" the new library building to its history in a feasible manner.

### The proposed project involves:

- Demolition / deconstruction of the existing library building (approx. 1,000 sq. ft.) at 37750 Sacramento Street and existing residence (approx. 1,150 sq. ft.) on adjacent lot at 14184 Second Street
  - Yolo Fire Protection District is interested in potential controlled-burn training exercise as a means to remove residence
- Construction of the new Yolo Branch
  Library building (one-story, approx.
  3,800 sq. ft.), with community mtg. room
- Lot merger (to 0.65-acres) and rezone to Public/Quasi Public use
- Operation of the new library

# Why did the Yolo County Library Prepare an EIR?

(EIR Ch. 1, 2, and 4)

The proposed project would demolish a historical resource (the existing library), which is a significant impact under CEQA and requires the preparation of an EIR.

The EIR process provides maximum opportunity for agency/public participation.

Draft EIR development included Notice of Preparation (NOP), agency coordination, preparation of a Historical Resources Report (by JRP Historical Consulting, LLC), other research and analyses.

## The Draft EIR identifies no/less than significant impacts on:

• Agricultural and Forestry Resources, Geology and Soils, Greenhouse Gases, Land Use and Planning, Mineral Resources, Population and Housing, Public Services, Recreation, Transportation, Utilities and Service Systems

# The Draft EIR identifies potentially significant impacts on:

- Aesthetics, Air Quality, Biological Resources, Cultural/Tribal Cultural Resources, Hazards, Hydrology/Water Quality, Noise and Vibration
  - Most impacts (7 out 12) are temporary, construction-related impacts, including impacts from potential controlled burn activities: AES-1, AIR-1, BIO-1, CUL-3 (including tribal cultural resources), HAZ-1, HYD-1, and NOI-1
  - Mitigation measures for construction-related impacts include preconstruction surveys for resources, construction monitoring, community notification of construction activities, etc.

The Draft EIR identifies potentially significant permanent / operations-related impacts on:

- Aesthetics (AES-1): Existing building's architectural style has been part of Town for 100 years; the Yolo County Library would incorporate character-defining architectural features of the existing library into the new project design.
- Hydrology (HYD-2 and HYD-3): Stormwater and flooding impacts addressed through site design mitigation
- Noise (NOI-2): Community use of the library must end by 9:00 PM, amplified sound is prohibited during community meetings.
- Cultural (Historical) Resources (CUL-1 and CUL-2): Demolition of the existing historical library building

The Draft EIR identifies 4 mitigation measures pertaining to demolition of the existing Yolo Branch Library building :

- CUL-1A: Documentation and recordation of the existing building
- CUL-1B: Incorporate interpretive materials into final project design.
- CUL-1C: Salvage Plan to identify and incorporate architectural design/specific elements into final project design.
- CUL-1D: Seek funding to preserve and relocate the building.

These measures would document significant physical characteristics, inform the community and public about the library's history, and salvage and reinterpret certain important architectural elements . . . . But, they may not avoid the demolition of the library.

Impact CUL-1 is a **significant and unavoidable** impact, even with feasible mitigation measures.

# The Draft EIR identifies 7 potential alternatives:

- 5 alternatives are rejected from detailed consideration because they are infeasible, would not obtain most of the project's objectives, and/or do not avoid or substantially lessen the project's significant impacts:
  - Rehabilitate the Existing Library Building, Expand the Existing Library Building, Preserve the Existing Library Building, Alternative Site Location, Temporary Service Options
- No Project Alternative: Continues interim library services from the modular this alternative does not achieve any project objectives and may avoid demolition in the near-term, but not in the long-term.
- Reduced Project Alternative: Results in approx. 2,000 to 2,500 sq. ft. new library building without community room this alternative achieves half of the project's objectives, but does not avoid demolition of the library.

# New Yolo Branch Library Building Project Benefits

Environmental, social, economic, and other benefits of the project:

- Provides new, larger library that can better serve the area and meet library service goals
- Increases access to information, particularly digital information
- Redevelopment minimizes impacts associated with "greenfield" development – less habitat loss, less new impervious surface area
- Redevelopment promotes increases in efficiency less GHG emissions
- New public/civic structure enhances the Town
- The design and construction of the new library project provides highskilled architecture, engineering, and construction jobs

# What is the Project CEQA Process?

The Yolo County Library is the CEQA Lead Agency for the project. The EIR process includes:

- 1) Nov. 2017 Notice of Preparation and Public Scoping Meeting
- 2) Publish Draft EIR July 20, 2018
  - 45 day review and comment period
  - Closes Tuesday, Sept. 4, 2018
- 3) Publish a Final EIR
  - Responds to comments on Draft EIR
  - Identifies project revisions / EIR errata
- 4) Prepare Statement of Overriding Considerations, certify Final EIR, approve project
  - Occurs at Board of Supervisors hearing
- 5) File Notice of Determination

  - The EIR should not limit the time the meeting room can be used.
  - The EIR should provide more detail on the Salvage Plan identified in Mitigation Measure CUL-1C.
  - The EIR should consider an additional alternative to the project.
- All comments become part of the record, including comments for or against the project.
