The Yolo County Board of Supervisors met on the 2nd day of July, 1998 in special session in its Chambers in the Erwin Meier Administration Center, Woodland, California at 9:00 A.M.. All members were present. Chairman Pollock presided. Victor Singh, Assistant County Administrator and Steve Basha, Assistant County Counsel were present.
