#### INTRODUCTIONS AND PROGRAM UPDATES

- SAM- system wide changes Drug Medical goes live July first, expansion to MH coverage and Heritage oaks will take over access line, recruitments going on with vacancy SUD System of Care, Access Clinician and two Case Managers, we will have case managers to help navigate. HHSA is hiring for QM analyst and QM clinician to fill vacancy
- DAVID-national making music day put out free music and he will be at E Street Plaza in Davis, free music all over town
- TICO- Rise summer strengths program held in Winters and Esparto. The kids went to Woodland pools and participated in other programs aimed to lessen the experience gap.
- LEIGH-Two new psychiatrist here today, handout Access Continuum Care Urgent care in West Sac Sutter doing NP side, toured with Sutter and will have prescriber in urgent care by end of month
- KIM-contract working on contract for providers, hiring crisis clinicians most work embedded in child responses
- NORA KIM-working in Davis as well as Thursday/Friday's in Woodland
- DR. KAN-working full time in Woodland and will be seeing some Safe Harbor clients which is part of YCC
- SARA-MAT has some unused funds that will expand what we will be able to cover. We can pay for medication and treatment in addition to many other resources that are available.
- NOLAN-Service Center located at 600 A Street in Davis is under construction and running behind but on target for budget. Between now and June 28, services will be impacted and adjusted. New Wellness Center will open in August. An open house will occur as a whole at project completion in October.
- LEIGH-Continuing to offer MH services and moving into new space this week

#### 1. DIRECTORS REPORT

*Continuum of Care group and committees have been aligned with intercept mappings, governors 18/19 budget, exciting news with additional funding for folks experiencing homelessness, Social Security income hold harmless agreement changed. Previously, people on SSI excluded from Cal fresh or food stamps, states have funded a mechanism to eliminate that agreement. Hold harmless will protect those who are newly eligible from income rise so no benefits can be lost, which will in turn increase participants who will qualify.*

3. SUD-Review documents of path to Access/Continuum of Care Heritage Oaks. Beginning July 1 client calls assessed and level of appropriate care determined. Demographics are to be collected at same time. By end of
