**9:00 A.M. CALL TO ORDER**

1. **WELCOME AND INTRODUCTIONS – Ron Chapman, Yolo County Health Officer**  
The June 14, 2018 Health County meeting was called to order at 9:03 a.m., at which time around the table introductions occurred and later quorum was confirmed.
2. **CONSIDER APPROVAL OF AGENDA – Ron Chapman, Yolo County Health Officer**

3. **APPROVE THE [MAY 10, 2018 MINUTES](#) – Ron Chapman, Yolo County Health Officer**

4. **PUBLIC COMMENT**
  - Tia Will asked about the Yolo County’s detention centers and the Office of Refugee Resettlement (ORR) program issues. Patrick Blacklock reported an update will be going to the Board of Supervisors regarding the ORR program on June 26.
  - John Troidl reported the California Healthcare Workforce Policy Commission is responsible for policy direction regarding health workforce in the State of California; and there has been a significant infusion of funding for supporting primary care education for family medicine, general and internal medicine, nurse practitioners, physicians assistants, and nurses.
  - Mark Ho asked if the Gun Related Harm/Gun Violence presentation for the September meeting be rescheduled to the October meeting.
5. **STATE AND COUNTY UPDATE – Patrick Blacklock, CAO**
  - Local Budget: The Board of Supervisors adopted the 2018-19 budget at the June 12 Board meeting. The budget is up quite a bit for Yolo County; but we have a significant number of capital improvement projects that will be underway in the coming year, which includes two jail projects and the Esparto Park and Pool Project.

In the General Fund, there was a reduction of 4.7 positions due primarily to the rise in pension costs; but we were able to balance all budgets and the positions associated with these reductions are currently vacant.

Health and Human Services Agency is primarily federal and state funded and will add 23 new positions this next fiscal year. The biggest component is the new drug Medi-Cal waiver program, which will provide expanded services to those seeking treatment for substance abuse.

- **County Medical Services Program (CMSP):** Has taken a second step to help the uninsured, undocumented population, with pilot projects for preventive healthcare. The goal is to have the pilot projects up and running in January 2019.
- **Adult Day Health Center:** We continue to collaborate with Dignity Healthcare on the expansion. Dignity has convened a group that consists of Mercy Housing, City of Woodland, Yolo County, and Yolo Housing to examine whether there might be a potential solution that brings not only a new facility for Adult Day Health; but also make an affordable housing complex and potentially an assisted housing within it.

#### 6. BOARD OF SUPERVISORS UPDATE – *Assistant Deputy Jessica Jones*

- **In Home Support Services (IHSS) Project:** Social Services is projecting a deficit of \$1.2 million in the Public Assistance Administration unit due to the new IHSS Maintenance of Effort resulting from the cost shift enacted by the State in 2017. It is important to note that there has been no county discussion about reducing services to beneficiaries.
- **Mental Health:** At the June 5<sup>th</sup> Board meeting, the Board approved two grant agreements with Mental Health Services Oversight, and Accountability Commission, to receive funding for the implementation of mental health triage programs for an aggregate amount of \$589,176 for the period of July 1, 2018 through June 30, 2021. Collectively, these grants will assist Yolo County in expanding crisis treatment services, reducing unnecessary hospitalizations, and expanding the continuum of services with early intervention and treatment options that are recovery oriented for children and youth. The grants will provide funding for four crisis clinicians; and the clinicians will be available for the target populations to offer crisis stabilization, outreach, engagement and direct service provision. The clinicians will work hours that are aligned with HHS's Urgent Care facility in West Sacramento, which is open from 12pm to 9pm, 7 days per week.

#### 7. COMMUNITY HEALTH BRANCH AND HEALTH OFFICER REPORTS – *Ron Chapman, Health Officer and Interim Community Health Director, HHS* [Branch Report](#)

- **Emergency Medical Services Agency:** Received the American Heart Association's Mission: Lifeline EMS Gold Award for the second year, which is an amazing honor.
- **Oral Health:** With the increase in tobacco tax, all counties in California are now receiving state funding to create Oral Health programs; and in this county it is about \$200,000 a year. As of January 1, 2018, we have been purchasing supplies for the program, health education materials, and models of teeth for staff to use when they go out in the field; and on July 1, 2018, we will have two dedicated staff working in the program.

The Oral Health Policy Summit in May was very successful. We had 30 people in attendance representing various organizations from around the county. The guest speakers included Supervisor Don Saylor, who welcomed everyone; Dr. Karen Smith, State Health Officer and Director of California Public Health was our keynote speaker; Dr. Lisa Chung, Professor of Dentistry and Preventive Dentistry at University of California San Francisco, lectured on oral health policies and oral health community work; we also had a panel who spoke on their individual perspectives on what is happening in the communities around the county and

around oral health. At the end of the meeting, everyone broke up into groups and discussed the four strategies around oral health. The groups came up with action steps for our Community Health Improvement Plan (CHIP), which is one of the deliverables for the state grant.

- **Cannabis:** With the new laws, there are very different approaches from one city jurisdiction to the next. One of the primary interests is around surveillance, and given the different policies in the different cities, there is interest in seeing what the impact is going to be over time.
- **Personnel:** Community Health Branch Director – Happy to announce that Brian Vaughn from Sonoma County will join us on June 25, 2018.

Outreach Specialist II – The Community Health Branch is in the process of hiring an Outreach Specialist, which will be working on Accreditation.

- **Community Health Assessment (CHA):** This year we have a different approach, we have more organizations involved, a great collaboration and things are really coming along.
